#### 1. Welcome

Russ Pigg welcomed the CCB members and staff and introduced Kate Ryan, Council's Community Engagement / CCB Officer. Attending councillors and staff were introduced.

#### 2. Presentation – IPART Rates Discussion, CSP and DPOP

Craig Milburn provided an update on the IPART determination <u>http://shoalhaven.nsw.gov.au/My-Council/News/ID/2363/Special-Rate-Variation-</u> <u>IPART-Decision</u> Craig outlined the five criteria that IPART used to make their determination, these include:

- Demonstrated need
- Community engagement and awareness
- Reasonable impact on rate payers
- Exhibition of IPR documents
- Productivity improvements
- Question: Is there a historical precedent for capital grants not being received by Council?
- Reply: Capital grants are generally received each year for varying purposes and the amount will fluctuate. This information is available from the Annual Financial Statements available on Council's website
- Question: Is information available about how Council uses capital grants money?
- Reply: Yes, councils are required under legislation to provide this information. Council's financial statements show net operating results with, and without capital grants. Financial statements are made available on Council's website every quarter and annually.
- Comment: Capital grants information should be displayed as a news event and not just as part of the financial statements.
- Reply: Ben Stewart noted that when Council receives a capital grant, information is made available on Council's website, for instance, when Council receives Black Spot funding.

Russ Pigg noted that the grants from Federal government (\$16.7M in the past) has been increased for the current year to just under \$30M.

Jessica Rippon provided an update on the Community Strategic Plan (CSP) and asked CCBs to encourage their members to visit Council's "Get Involved" website page <a href="http://getinvolved.shoalhaven.nsw.gov.au/csp">http://getinvolved.shoalhaven.nsw.gov.au/csp</a> where they can "have their say". Over

1200 internet surveys have been received. Drop-in days, community workshops and public meetings were also scheduled. The CSP will be on exhibition until 26 May 2017. Jessica noted that Council is also seeking feedback on its draft Delivery Program, Operational Plan (DPOP) and Budget for 2017-2018 (on exhibition until 26 May 2017). As part of the consultation process public meetings held in May provide residents with the opportunity to ask questions and find out more about the plan.

Residents can also have their say about the DPOP, Fees and Charges, Budget and Capital Works, Pools, Aquatics and Leisure Centres and Shoalhaven Family Day Care via the website <u>http://getinvolved.shoalhaven.nsw.gov.au/integrated-strategic-plan</u>

#### 3. Presentation – Insurance and the Role of CCBs

Melissa McCoy addressed the CCBs with regard to insurance coverage for CCB community projects and representations/allegations made against CCBs.

Council operates through State Wide Mutual which insures local government entities and official committees of council. CCB's cannot be insured through this as CCBs are third party community groups.

CCBs general meeting activities falls under Council public liability insurance cover i.e. for individual members of CCBs for their meetings in council facilities

Council has insurance for specifically named community footpath projects. If they wish community projects to be covered, a project submission must be made to, and adopted by, Council.

#### Question: How can CCBs protect themselves?

Reply: Insurance needs depend upon how community groups are formed. An incorporated community group means it is registered as a legal entity. Council can assist CCBs with the facilitation through a local community insurance scheme if required. Council cannot protect CCBs from litigation

A representative from the Berry Forum made reference to a current defamation case.

Melissa explained about Council's legal responsibility to release information under the Government Information (Public Access) Act.

It was noted that defamation only comes into play when opinions/comments are made that may damage the reputation of an individual or their future earnings.

- Question: Hyams Beach Villagers Association asked about CCB's liability and what Council covers for those bodies incorporated and non-incorporated. It was requested that a working paper, outlining all information, should be sent to all CCBs.
- Reply: Russ Pigg noted that CCBs are an extension of the community and are not appointed by Council. CCBs are not representing, or acting on behalf of Council. Council acknowledges that CCBs are a valuable channel of communication to the community and guidelines apply.

- Question: Basin Villages Forum asked if it would be possible for Council to check through documentation that CCBs generate.
- Reply: Council would not have the capacity to do this and legally cannot provide legal advice. It was noted that issues arise when comments or allegations are made about individuals.

Callala Bay Community Association noted that care should be taken to be objective and not make personal comments.

- Note: A member of The Pride of Bomaderry CCB stated that, as the CCB is an organisation standing on its own he is resigning his CCB membership.
- Question: Berry Forum asked if clarification / practical guidelines and information about liability could be provided by Council so that CCBs can make appropriate decisions with regard to insurances such as professional indemnity.
- Reply: An Information paper will be prepared for CCBs by the end of June. It was noted that Council will consider other community consultative models around the State.


