Important Information about lodging a declaration

Disclosure periods

A declaration lodged by or on behalf of a candidate must cover a specific disclosure period.

Read the questions below to determine the commencement date of the candidate's disclosure period.



Audit requirement

If this declaration is with respect to a local government election it must be reviewed and signed by a registered company auditor before it is lodged with the Election Funding Authority if at least one of the following criteria is met:

- the declaration contains more than \$2,500 in political donations, or
- the declaration contains more than \$2,500 in electoral expenditure.

If this declaration is with respect to a state by-election it must be reviewed and signed by a registered company auditor before it is lodged with the Election Funding Authority if the candidate is also lodging a claim for payment for the by-election.

Supporting documents to provide with the declaration

You are required to submit with this declaration the triplicate copy of each receipt or acknowledgement slip issued to the donors who made a reportable political donation to or for the benefit of the candidate during the disclosure period. Each receipt/acknowledgement must contain the name and address of the donor, the ABN of the donor if they are not an individual, the date the donation was made, the amount or value of the donation, the purpose of the donation and a description of the donation (in the case of non-monetary donations).

In addition, you are required to submit with this declaration copies of the invoices or receipts received in respect of all advertising and printing expenditure.
