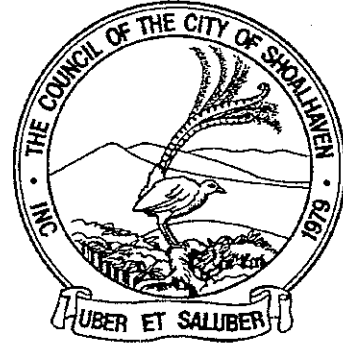

1.1 INTRODUCTION/BACKGROUND

In the process of considering a subdivision application for the development of five allotments on Portion 17, Parish of Broughton, Council has identified the need to amend the benefit areas relating to the upgrading of Bundewallah and Irvine Roads to more accurately reflect access being provided from Irvines Road.

In this regard, Portion 17, Parish of Broughton will benefit from the upgrading works along Irvine Road and the consequent contribution rates applicable to this project should be re-assessed.

In light of these developments, the contribution rate/benefit area for upgrading works along Bundewallah Road should also be re-assessed accordingly.

1.2 PURPOSE OF THE PLAN

The purpose of the plan is to re-assess and amend the benefit areas and contribution rates now applicable to projects 01 ROAD 020 and 01 ROAD 021 respectively.

1.3 LAND TO WHICH THE PLAN APPLIES (cl41F(b) EP&A Regs 1980)

The plan applies to land within benefit areas 01 ROAD 020 and 01 ROAD 021 (see attachment).

1.4 DEVELOPMENT TO WHICH THIS PLAN APPLIES

This plan applies to the subdivision and development of land contained within the relevant benefit areas.

2.0 ESTABLISHMENT OF NEXUS

2.1 01 ROAD 020 : Bundewallah Road

Upgrade gravel pavement

01 ROAD 021 : Irvines Road

Upgrade gravel pavement

2.2 NEXUS

It will be necessary to upgrade the gravel pavement on both Bundewallah and Irvine Road to cater for the additional demand which future development will generate.

2.3 APPORTIONMENT OF COSTS (CI41F(d) EP&A Regs 1980)

The costs of road upgrading will be divided between the subdividers of the land within the benefit areas on the basis of additional traffic generated by each additional equivalent tenement.

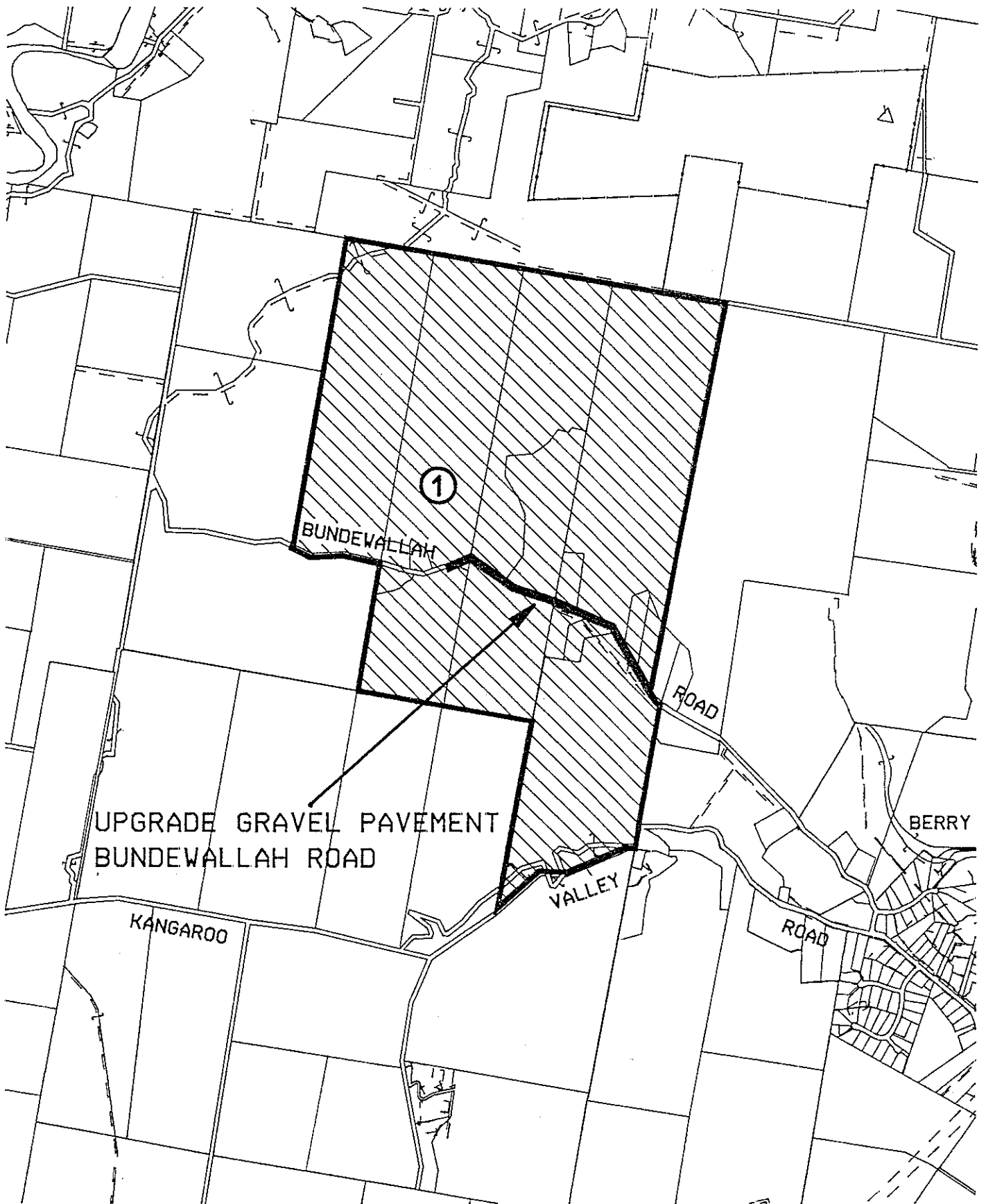

The method of payment will be by way of a contribution per lot on release of the Linen Plan.

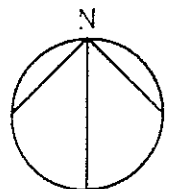


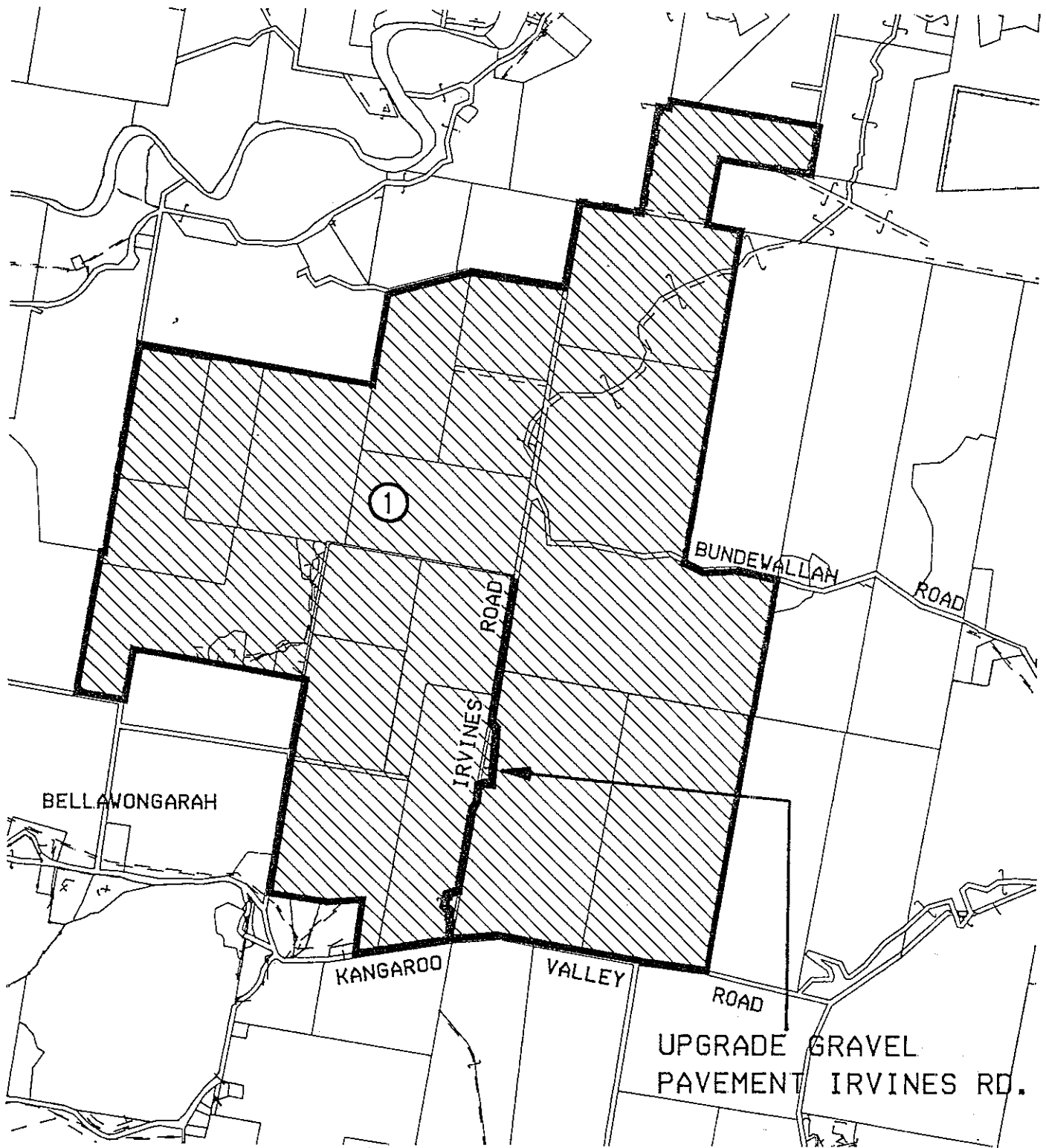

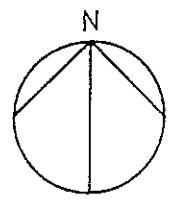
