1.1 INTRODUCTION/BACKGROUND

In the process of considering a subdivision application for the development of five (5) allotments on Portions **6**8, 106 and 107 Parish of Illaroo, situated off Main Road, Cambewarra, Council has identified the need to amend the number of benefiting equivalent tenements relating to the upgrading of 800 metres of gravel pavement west of Bangalee Road (01 ROAD 0033) and the upgrading of the timber bridge on Main Road (01 ROAD 0034).

This has become necessary because this subdivision comprises an additional equivalent tenement (allotment) as provided for under the new interpretation of clause 11. That is, the creation of three (3) concessional lots, a residue (1) plus one (1) x 40 hectare allotment - a total of five (5) lots.

The rate of contributions per lot, as set out in the current Contributions Plan, has been calculated on the basis of three (3) concessional lots being created out of an existing holding of 40 plus hectares.

As a consequence, the contribution rate per lot, for upgrading both the timber bridge and gravel pavement on Main Road should be reassessed accordingly in order to achieve an equitable rate of contribution.

1.2 PURPOSE OF THE PLAN (Cl.41 F(b), EP&A Regs 1980)

The purpose of the plan is to reassess the contribution rates currently applying to projects 01 ROAD 0033 and 01 ROAD 0034.

1.3 LAND TO WHICH THE PLAN APPLIES (CI. 41F(B), EP&A Regs. 1980)

The plan applies to land within the benefit areas of projects 01 ROAD 0033 and 01 ROAD 0034, being Lots 3 and 4, DP 591679, Lots 1, 2 and 3, DP 813495, Portions 56, 68, 106, 107 and 111 Parish of Illaroo and Lot 4, DP 593138 (see attachments).

1.4 DEVELOPMENT TO WHICH THIS PLAN APPLIES

This plan applies to the subdivision and development (including the construction of a dwelling/s) of the land contained within the relevant benefit areas, where such subdivision and/or development generates a demand for the subject services and/or facilities.

2.0 ESTABLISHMENT OF NEXUS

2.1 01 ROAD 0033: MAIN ROAD, CAMBEWARRA

Upgrade gravel pavement for 800 metres west of Bangalee Road.

01 ROAD 0034: MAIN ROAD, CAMBEWARRA

Upgrade timber bridge located towards the western end of Main Road across a tributary to Tapitallee Creek.

2.2 NEXUS (CI. 41F(b) EP&A Regs.1980)

Gravel pavements have a limited life due to the loss of gravel from the pavement due to traffic usage and climatic conditions. The rate of wear and the standard of pavement required is increased with higher traffic volumes. Consequently, the gravel pavement will require strengthening sooner, if further development generates additional traffic onto the road.

Shoalhaven City Council has developed a strategy to strengthen existing gravel roads to provide a suitable level of service for the increased traffic volumes. This work involves the strengthening of the road pavement and, in some cases, may involve additional upgrading work such as:

- (a) widening specific areas; and/or
- (b) upgrading or providing culverts at specific locations.

Strengthening of the gravel pavement may involve increasing the pavement thickness and/or using mechanical or chemical stabilisation techniques.


It will be necessary to upgrade the gravel pavement on Main Road for a distance of 800 metres west of Bangalee Road to cater for the additional demand which future development will generate.

The existing timber bridge on Main Road, across the Tapitallee Creek Tributary, will require upgrading to a concrete box culvert to accommodate the additional demand which future development will generate.







2.3 APPORTIONMENT OF COSTS (Cl.41 F(d), EP&A Regs. 1980)

The costs of bridge and road upgrading will be divided between the subdividers of the land within the benefit areas on the basis of additional traffic generated by each additional equivalent tenement (dwelling).

- ie 01 ROAD 0033: Estimated cost = \$24,300

 Benefit Area comprises 5 existing + 7 potential which = 12

 lots (ETs)
 - cost per ET = $$24,300 \div 12 = $2,025$
 - Estimated Council responsibility = $(5 \div 12) \times \$24,300 = \$10,125$
 - Estimated developer responsibility = $(7 \div 12) \times \$24,300 = \$14,175$

01 ROAD 0034 : estimated cost = \$95,900

Benefit Area comprises 1 existing + 7 potential = 8 lots (ETs)

 \sim cost per ET = \$95,900 ÷ 8 = \$11,988

Estimated Council responsibility = $(1 \div 8) \times \$95,900 = \$11,988$ Estimated Developer responsibility = $(7 \div 8) \times \$95,900 = \$83,912$
