

# **Explanatory Document**

# Amendment No. 8 (Housekeeping) to Shoalhaven Contributions Plan 2019 (CP2019.8)

#### Overview

The Shoalhaven Contributions Plan 2019 (the Plan) is a web-based plan that allows Council to levy monetary contributions on development consents and complying development certificates issued for the development of land within Shoalhaven. These contributions are collected to enable the provision of community infrastructure projects (as detailed in the Plan) to meet demand created by development.

## **Background**

The proposed housekeeping Amendment applies to Schedule 2 – Old Subdivision Properties of the Plan. The Plan provides a mechanism for the levying of development contributions for land which is the result of a subdivision approved prior to 1993 that has subsequently been rezoned to enable development. These are known as 'old subdivision properties' (OSP's). For further information on OSPs, refer to Section 2 of the Plan.

However, during the implementation of Amendment No. 1 (Housekeeping) to the Plan (which came into effect on 5 March 2021), an administrative error was discovered with the list of OSP's in Schedule 2 of the Plan. Currently, Schedule 2 consists of the properties that should have been removed as part of Amendment 1.

This draft Amendment proposes to resolve the administrative error and ensure that the correct list of OSP's is provided in Schedule 2 of the Plan by deleting the current OSP list and inserting the content of the table at Attachment 1 in its place.

### **Proposed Changes**

The proposed amendment to Schedule 2 of the Plan intends to replace the OSP list that currently makes up Schedule 2, with the content of the table at **Attachment 1** being inserted in its place.
