1. Tender - Burrill Lake Pump Station Upgrade

File 35754

Summary

Three pump stations in Burrill Lake require upgrading as part of the overall Milton/Ulladulla Sewerage Scheme Upgrade and also to provide capacity for the transfer of wastewater from the Tabourie Lake Sewerage Scheme and proposed growth in the Dolphin Point area.

Pump Station Upgrade

Existing pump stations No. B1, B3 and B4 in Burrill Lake (see Attachment 1) require upgrade for OH & S, operational and capacity reasons. The upgrades are part of the overall Milton/Ulladulla sewerage scheme development that has included the new treatment plant. There is a total of 28 pump stations in the Milton/Ulladulla area to be upgraded. The remainder of the pump stations will be upgraded in three construction packages over the next three years.

The Burrill Lake upgrade replaces the existing with new pump stations and includes buildings for switchboards in the three locations. The estimated cost of the contract is \$3.96m (incl GST) and funds are available.

The Department of Commerce (Wollongong) has been engaged to undertake the tendering and evaluation process, and will manage the contract on Council's behalf.

Tender Evaluation

Tenders were called on 22 January 2007 and closed in Wollongong on 27 February 2007 with only three tenders being received as follows:

Tenders have been evaluated and in particular the lowest conforming tender from Firedam Constructions Pty Ltd. Firedam are currently finishing the Conjola Transport System Contract and is capable of completing the tender to the required standard and program. Final tender negotiations have not been finalised at this point in time and an Addendum Report will be provided prior to the meeting with recommendations for Council's consideration.

The Draft Tender Evaluation Report is in the Councillors information folder.

RECOMMENDED that Council consider the tenders for the upgrade of Burrill Pump Stations B1, B3 and B4.

2. Berry Pump Station Upgrade and Sewer Rising Main extension, Bomaderry

Files 1371-02, 24438-01

Summary

Five Pump Stations in Berry require upgrading as part of the overall Berry Sewerage Scheme upgrade that included the new treatment plant recently completed. Pump Stations 1, 5 and 6 are proposed to be upgraded in this contract, with the remaining two to be upgraded at a later time. (See Attachments 1 and 2)

The contract also includes the upgrade of infrastructure in Bomaderry to accept the flows from a recently upgraded pumping station at Cambewarra.

Infrastructure Works

Whilst Pump Stations 1 and 6 at Berry will be upgraded, however Pump Station 5 will replace an existing pump station in Victoria Street and provide capacity for new development to the west of the Princess Highway and adjacent proposed SEPP5 Development. The Bomaderry works include an extension of the Cambewarra Rising main and gravity sewer east of the highway. Whilst these works are not connected they have been bundled into the one contract for economies of scale. The location of the works is shown on the attached plan.

The estimated cost of the works is \$1,175,000 (incl GST) and funds are available.

Tender Evaluation

The Department of Commerce has been engaged to undertake the tendering process and to also manage the contract on Council's behalf. Tenders were called on the 7 March 2007 and closed in Wollongong on 3 April 2007 in Wollongong with six tenders being received as follows:

1. Tender - Burrill Lake Pump Station Upgrade

Summary

This is an Addendum report to that shown in the Business Paper and provides additional information and alternative recommendations. The report in the Business Paper and tender evaluation advised of final negotiations with the lowest conforming tender, Firedam Civil Engineering Pty Ltd. The outstanding matter is an Addendum to the tender that is to be priced by Firedam and forming part of the tender.

Additional Information

In order to let the tender, the Department of Commerce has included a conservative sum of \$150,000 for the addendum works in the tender, as a provisional sum, pending the final negotiated price from Firedam. This has been included in the final tender recommendation shown in Councillors' Information Folder, with a final adjusted tender amount of \$3,267,100.96 (exc. GST). Whilst Firedam Civil Engineering Pty Ltd may require additional supervision (as discussed in the tender evaluation report) they have the technical and financial capacity to undertake the works as required and are still significantly less than the next lowest tenderer.

RECOMMENDED that Council:

- a) Accept the tender from Firedam Civil Engineering Pty Ltd for the adjusted tender amount of \$3,267,100.96 (exc. GST) for Contract No. 0602585 for the Milton Ulladulla Sewerage Augmentation Burrill Lake Pump Station Upgrade.
- b) Authorise the General Manager (Shoalhaven Water) to adjust the contract for rise and fall variations for components of the contract

2. Tender - Berry Pump Station Upgrade and Sewer Rising Main Extension Bomaderry File 1371-02, 24438-01

Summary

This is an Addendum report to that shown in the Business Paper, providing additional information and revised recommendation for the upgrade of three sewage pumping stations in the Berry Sewerage Scheme and the Cambewarra Sewerage Scheme Sewer Rising Main No. 23 at Bomaderry.

Additional Information

The report in the Business Paper and accompanying tender evaluation advised that the tender from Select Civil Pty Ltd had been assessed as the lowest conforming tender and propose acceptance subject to financial checking. The financial assessment has yet to be confirmed at time of writing.

It is proposed that the tender submitted by Select Civil Pty Ltd for the amount of \$810,626.10 (exc.GST) be accepted, subject to written confirmation of a satisfactory financial assessment.

RECOMMENDED that Council:

- a) Accept the tender from Select Civil Pty Ltd for the adjusted tender amount of \$810,626.10 (exc. GST) for Contract No. 0602406 for the upgrade of three (3) Sewage Pumping Stations at Berry and Extension of Sewer Rising Main No. 23 at Bomaderry
- b) Authorise the General Manager (Shoalhaven Water) to adjust the contract for rise and fall/variations for components of the Contract.

Note: The following resolution was adopted at the Council meeting held on Tuesday 24th April, 2007:

RESOLVED on a MOTION of Clr Willmott, seconded Clr McCrudden that Council:

- a) Adopt the Draft DCP No 54 for Huskisson CBD subject to the following:
 - *The terminology "Tourist Town" be retained within the wording of the DCP and for hierarchical considerations;*
 - ii) The following bonus provisions be incorporated for buildings that demonstrate high architectural merit and a high degree of articulation:
 - On the northern side of Owen Street a maximum of up to four storeys where the development site consists of two or more lots and has a minimum area of 1200 square metres.
 - On the southern side of Owen Street a maximum of up to five storeys where the development site consists of two or more lots and has a minimum areas of 1200 square metres with a maximum of 50% floor space coverage on a sixth level for sites over 3000 square metres.
- b) Reactivate dialogue with National Parks and Wildlife Service in relation to the proposed bypass of Huskisson.
- c) Council advertise the following proposed amendment to the Development Control Plan No 54 in relation to Lot 2, DP 471682:
 - Limiting development to a FSR of 1:1
 - A 12 metre setback from Currambene Street.
