# Chapter 3

# **Section 8(1) - The Council's Charter**

## **Summary**

In accordance with the Water Supply Developer Servicing Plan – Capital Works Program tenders were called and evaluation completed for the construction of a 300 diameter water trunk main to boost water supply and pressure to the high part of Flinders Industrial Estate.

## **Background**

The Flinders Industrial Estate at South Nowra has been expanding as a result of demand for industrial land. A water supply hydraulic analysis study for the area served by the South Nowra industrial reservoir found the need to boost water supply and pressure to the high part of Flinders Industrial Estate. The infrastructure was then included in the 2005 Water Supply Developer Servicing Plan. In addition it will also have capacity to support the proposed Shoalhaven Correctional Facility if required.

## **Water Supply Infrastructure Works**

# The water supply works involves the construction of approximately 3000m of 300 diameter MPVC water main from South Nowra industrial reservoir to the high part of Flinders Industrial Estate (see Attachment 1). The works will traverse through some private lands and easement for water supply will be acquired over the affected lands.

## **Tender Evaluation**

Tenders were called and evaluated by the Department of Commerce for the construction of approximately 3000m of 300 diameter MPVC water main at South Nowra. Tenders were called on 20 December 2006 and closed in Wollongong at 9:30am on 31 January 2007 with four (4) tenders being received as follows:

# Tenders were evaluated for conformance with the specifications and adjusted for mathematical errors, supervision costs and estimated contingency amounts. With this adjustment the conforming tender from AWPM P/L for \$885,480.00 was the lowest adjusted amount. See the tender evaluation in the Councillor's Information Folder.

## **RECOMMENDED that:**

- a) Council accept the tender from Australian Water Project Management Pty Ltd (AWPM P/L) for the construction of the 300 diameter trunk main at South Nowra for \$885,480.00 (including GST)
- b) The Tender Document be executed under the Seal of Council
- c) Council authorise the General Manager (Shoalhaven Water) to adjust the contract for rise and fall/variations for components under the contract
