



## **SHOALHAVEN TRAFFIC COMMITTEE**

Commencing at 9.30AM**

The City of Shoalhaven Traffic Committee is not a committee of Shoalhaven City Council under the Local Government Act 1993, but a technical review committee. The Committee operates under the authority conferred to Council by the Roads and Maritime Services (RMS) under the Transport Administration Act 1988 (Section 50).

Council has been delegated certain powers, from the RMS, with regard to traffic matters upon its local roads. A condition of this delegation is that Council must take into account the Traffic Committee recommendations.

There are four permanent members of the Traffic Committee, *each of whom has a single vote only.*

- The members are representatives of the NSW Police Force, RMS, the Local State Member of Parliament (for the location of the issue to be voted upon), and a representative of Shoalhaven City Council.
- If the RMS or NSW Police Force disagrees with any Traffic Committee recommendation, or Council's resolution on any Traffic Committee recommendation, that member may lodge an appeal with the Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of Council's resolution. Any action relative to any issue under appeal must cease until the matter is determined. The Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

### **IMPORTANT NOTE:**

The Council can only:

1. Adopt the Traffic Committee recommendation
2. Not Adopt the Traffic Committee recommendation
3. Request the Traffic Committee reconsider the issue.

Council cannot amend a Traffic Committee recommendation, but can raise other issues as Additional Business at either the Ordinary Meeting or the Strategy and Assets Committee.

2. Parking Restrictions - Paradise Beach Road, Sanctuary Point (PN 96) File 2942E

RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to 2 hour (2P) parking restrictions for a distance of 20m being installed on the southern side of Paradise Beach Road, Sanctuary Point, adjacent to Sanctuary Point Library, time restricted to 10am-5.30pm Mon-Fri, 9.30am-12.30pm Sat, as detailed in TRAF 2016/05.

3. Road Safety - Intersection of Tallwood Avenue and Mitchell Parade, Mollymook Beach (PN 1823) File 2948E

15. Additional Item – Traffic Committee Inspections File 1491E

Allan Trass advised the Committee that he had received information via email from the office of Shelly Hancock MP that will require Traffic Committee inspections.

16. Additional Item – ANZAC Day Road Closures File 8601E

Clr White asked when information about the road closures for ANZAC Day will be released.

It was noted that ANZAC day road closures are in progress and information will be released in the near future.

17. Additional Item – Cow Creek Bridge, Sussex Inlet Road File 13834E

Clr White raised the issue of vegetation growing where a large tree fell in the creek near Cow Creek Bridge. The vegetation is limiting driving sight lines when travelling over the 2<sup>nd</sup> Cow Creek Bridge.

The Traffic Investigation Officer noted that the vegetation had been cleared some time ago and that he would refer the issue on again as a maintenance request.

18. Additional Item – Speed Limits on Princes Highway File 6852E

Clr White asked if changes to reduce the speed limits on the Princes Highway between Falls Creek and Wandandian will be considered in the future due to the high number of road crashes in the area.

Nathan Boscaro noted that Roads and Maritime Services are looking at the speed zones around Island Point Road and the outcome of black spot submissions will be known soon.

Roads and Maritime Services also noted that have also secured funding in 2016/17 to improve the intersection of Princes Highway and Hawken Road near the Log Cabin Service Station at Tomerong.

It was noted that some speed zones through Nowra are also under review.

There being no further business, the meeting concluded, the time being 10.20 am.

**1. Confirmation of Minutes**

---

The report of the Shoalhaven Traffic Committee meeting held on 8 March 2016 is attached. The report and recommendations contained therein were submitted to Council at its meeting held on 15 March 2016. All recommendations were adopted.

**2. Road Safety - Intersection of Grange Road and The Wool Road, St Georges Basin (PN 1209)** **File 1713E**

---

The committee may recall previous discussions in relation to the intersection of The Wool Road and Grange Road, St Georges Basin.

Council has received concerns from a resident in relation to crashes that have occurred at the intersection.

Council traffic staff inspected the intersection and recommend the following enhanced delineation be considered at the intersection:

- a) Extend E1 linemarking 20m into Grange Road
- b) Install C1 linemarking across the intersection, on the alignment of the curve to delineate the eastbound travel lane on The Wool Road
- c) Remark and extend the BB linemarking on the curved alignment to allow a 10m gap centralised over the intersection
- d) Existing turn warning sign and 35km/h supplementary speed advisory signs on The Wool Road on both approaches to intersection to be duplicated
- e) Grade shoulder of grass and debris to reveal existing E1 linemarking on The Wool Road
- f) Remark all linemarking east and west of the intersection for a distance of 100m and install centreline and edgeline RRPMS at 12m spacings
- g) Remark all linemarking north of the intersection for a distance of 30m and install centreline and edgeline RRPMS at 12m spacings

NSW Roads and Maritime Services (RMS) have advised Council that the current 80/60 speed zone change point currently located on the Wool Road, east of the Grange Road has been approved to be relocated west of the Grange Road.

This will reduce the approach speed at the intersection from 80km/h to 60km/h on The Wool Road.

---

**RECOMMENDED** that the General Manager (Director Assets and Works) be requested to install the following linemarking and signage upgrades at the intersection of Grange Road and The Wool Road, St Georges Basin as detailed in the attached diagram TRAF 2016/18:

- a) Extend E1 linemarking 20m into Grange Road**
- b) Install C1 linemarking across the intersection, on the alignment of the curve to delineate the eastbound travel lane on The Wool Road**
- c) Remark and extend the BB linemarking on the curved alignment to allow a 10m gap centralised over the intersection**
- d) Existing turn warning sign and 35km/h supplementary speed advisory signs on The Wool Road on both approaches to intersection to be duplicated**
- e) Grade shoulder of grass and debris to reveal existing E1 linemarking on The Wool Road**
- f) Remark all linemarking east and west of the intersection for a distance of 100m and install centreline and edgeline RRPMS at 12m spacings**
- g) Remark all linemarking north of the intersection for a distance of 30m and install centreline and edgeline RRPMS at 12m spacings**

### 3. Temporary Road Closures for ANZAC Day Services and Marches (PN 2776) File 8601E

Requests for various ANZAC Day marches to be held throughout the City have been received by Council.

The following services and marches are proposed and will require temporary road closures to ensure the safety of the participants and road users.

Berry – Assemble in Queen Street adjacent to Apex Park at 10.20am. The march will move off at 10.30am via Queen and Alexandra Streets to War Memorial Gardens for a one (1) hour service.

Bomaderry – Dawn Service in Walsh Memorial Park, Meroo Street commencing at 5.45am  
Memorial Service – Assemble in Bunberra Street adjacent to Bomaderry RSL Club at 9.00am and march to Walsh Memorial Park in Meroo Street at 9.15am via Bunberra and Meroo Streets for service at 9.30am.

Callala Beach – A Memorial Service will be held at the Cenotaph in the grounds of the Callala RSL Country Club commencing at 10.00am.

**Bomaderry – Dawn Service in Walsh Memorial Park, Meroo Street commencing at 5.45am**

**Memorial Service – Assemble in Bunberra Street adjacent to Bomaderry RSL Club at 9.00am and march to Walsh Memorial Park in Meroo Street at 9.15am via Bunberra and Meroo Streets for service at 9.30am.**

**Callala Beach – A Memorial Service will be held at the Cenotaph in the grounds of the Callala RSL Country Club commencing at 10.00am.**

The committee may recall previous discussions in relation to the GP Super Clinic on Scenic Drive, Nowra.

An amended signage and linemarking plan for the GP Super Clinic on Scenic Drive, Nowra has been submitted for the Committee's consideration.

The amended plan includes signage and linemarking associated with proposed relocation the entrance driveway from the Cancer Care Centre carpark to Scenic Drive.

The 90 degree on street parking spaces removed as part of driveway entrance will be relocated in various areas in the precinct (separate approvals process).

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the regulatory signage and linemarking proposed as part of the access amendments for the GP Super Clinic, Scenic Drive, Nowra as detailed in the attached TRAF 2016/19.**

5. **Proposed additional vehicle control measures - Heritage Estates, Worroving Heights (PN 3260)** **File 1446E**

---

The committee may recall previous discussions regarding vehicle control measures, Heritage Estates, Worroving Heights.

Following the outcome of community consultation in relation to the original proposal, a further plan for additional vehicle control measures has now been submitted for the committee's consideration.

Under Section 116 of the NSW Roads Act 1993, Council proposes to install:

- A locked gate and barriers across Birriga Avenue between Lots 25 and 56 DP 8771 (west of the Greek Orthodox Church)
- Steel cable and post/boulder fencing on the western side of Naval College Road between Wanawong Boulevard and Erowal Bay Road.

The proposed measures are in addition to those that were referred to the STC on 9 February 2016, arising from submissions made to that proposal.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the following proposed vehicle control measures being installed as detailed in the attached diagram TRAF 2016/20:**

- a) **A locked gate and barriers across Birriga Avenue between Lots 25 and 56 DP 8771 (west of the Greek Orthodox Church), and**
- b) **Steel cable and post/boulder fencing on the western side of Naval College Road between Wanawong Boulevard and Erowal Bay Road.**
- c) **All control measures are to be located outside the clear zone**

---

6. **Relocation of Visitor Information Centre to the Shoalhaven Entertainment Centre (PN 3261)** **File 1478E**

---

Following a review of the Visitor Information Centre and the Shoalhaven Entertainment Centre services, Council has made a decision to relocate the Visitor Information Centre to the Shoalhaven Entertainment Centre in Bridge Road, Nowra.

To accommodate the proposal to relocate the Visitor Information Centre to the Shoalhaven Entertainment Centre, Council's Director Corporate and Community Services Director has requested amendments be considered to the regulatory parking restrictions on the northern side of the Entertainment Centre carpark.

It has been suggested to amend the existing 4 x 30 minute (1/2P) parking spaces and 9 x 2 hour (2P) parking spaces time restricted (9am-5pm Mon-Fri) to 13 x 1 hour (1P) parking spaces time restricted (9am-5pm Mon-Fri).

Additional to this, it has been suggested that to accommodate RV's, caravans and buses the existing No Parking - pick up drop off zones between the Entertainment Centre and the Administration building on both sides of the service road will be converted to No Parking - Vehicles and Combinations over 6m excepted.

This item was not included in the Committee's inspection itinerary.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the following amendments to the existing parking restrictions as detailed in the attached plan TRAF 2016/21:**

- a) Convert 4 x 30 minute (1/2P) parking spaces and 9 x 2 hour (2P) parking spaces time restricted (9am-5pm Mon-Fri) to 13 x 1 hour (1P) parking spaces time restricted (9am-5pm Mon-Fri)**
- b) Convert 28m existing No Parking - pick up drop off to No Parking - Vehicles and Combinations over 6m excepted on the eastern side of the service road between the Shoalhaven Entertainment Centre and the Council Administration Building**
- b) Convert 28m existing No Parking - pick up drop off to No Parking - Vehicles and Combinations over 6m excepted on the western side of the service road between the Shoalhaven Entertainment Centre and the Council Administration Building**

7. **Parking Restrictions - Leonard Street, Bomaderry (PN 3263)**

**File 2936E**

---

Council has been advised of concerns with vehicles parking in Leonard Street, between Peace Street and Shirley Street, Bomaderry.

Vehicles parked in this location are forcing traffic into opposing travel lane on a curve with restricted sight distance.

In view of addressing the concerns raised, Council is considering installing double barrier centre line marking for a distance of approximately 60m on the curve in Leonard Street (between Peace Street and Shirley Street).

The impact of this proposal will mean that motorists will be unable to park within 3m of the marked centre line.

This item was included in the Committee's inspection itinerary.

The inspection party noted that centre linemarking is warranted due to the lack of sight distance around the curve, especially when vehicles are parked in this location.

Consultation was carried out with affected property owners, residents and the Pride of Bomaderry.

One written submission and one verbal submission was received. One submission supports the proposal, and one objects to the proposal.

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to install Double Barrier (BB) centre linemarking for a distance of approx. 60m on the curve in Leonard Street, Bomaderry (between Peace Street and Shirley Street) as detailed in the attached TRAF 2016/22.**

8. **Give Way or Stop Sign - Edward Street, Berry (PN 3273)**

**File 1664E**

Fulton Hogan and Roads & Maritime Services (RMS) have advised Council 'near miss' incidents occurring at the intersection of North Street and Edward Street, Berry due to vehicles not giving way at the T intersection.

Council has been requested to consider installing a Give Way or Stop Sign on Edward Street at its intersection with North Street to reinforce to motorists of the T-Junction rule.

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to arrange for the installation of a Give Way sign and associated TB/TB1 hold line on Edward Street at its intersection with North Street, Berry as detailed in the attached drawing TRAF 2016/23.**

9. **Regulatory Signage and Linemarking - Central Avenue, South Nowra (PN 3275) File 51373E**

---

Council is undertaking road rehabilitation works on Central Avenue and Bellevue Street, South Nowra

Regulatory signage and linemarking plans for Central Avenue and Bellevue Street, South Nowra have been submitted for the Committee's consideration.

The rehabilitation works include upgrading the existing uni-directional hazard markers on Central Avenue at its intersection with Bellevue Street, and remarking of the existing BS centre linemarking on Central Avenue with BB centre linemarking in accordance with AS1742.2, north and south of Bellevue Street.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the regulatory signage and linemarking associated with the road rehabilitation works on Central Avenue, South Nowra, as detailed in the attached plan TRAF 2016/24.**

10. **No Stopping Zone Extension - North Street, Nowra (PN 3276)**

**File 1707E**

Council traffic staff have reviewed the parking restrictions at the intersection of North Street and Kinghorne Street.

To improve sight lines at this intersection, especially for motorists turning right into North Street from Kinghorne Street, it is proposed to extend the No Stopping by approx. 6m east of its current location.

A redundant driveway layback is located on the southern side of North St, east of Kinghorne Street. As this layback is now not utilised, vehicles parked in this location reduce sight distance for motorists turning out of Kinghorne Street.

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to arrange for the extension of the existing No Stopping zone a further 6m (approximately) east of its current location on the southern side of North Street, east of Kinghorne Street, Nowra, as detailed in the attached plan TRAF 2016/25.**

**11. Give Way Sign - Jasmine Drive, Bomaderry (PN 3277)**

**File 3995E**

Council has been requested to consider installing a Give Way sign on Jasmine Drive at its intersection with Meroo Road, Bomaderry.

Council traffic staff inspected the intersection and noted that the installation of a Give Way sign and associated hold linemarking at the intersection of Jasmine Drive and Meroo Road will assist in reinforcing the T intersection rule at this intersection.

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to arrange for the installation of a R1-2B Give Way sign and associated TB/TB1 linemarking on Jasmine Drive at its intersection with Meroo Road, Bomaderry as detailed in the attached TRAF 2016/26.**

**12. Regulatory Signage and Linemarking Plan - Wuru Drive, Burrill Lake (PN 3278)**

A signage and linemarking plan for the construction of roundabouts at the intersection of Wuru Drive / Macquarie Drive and Macquarie Drive / Superior Avenue, Burrill Lake has been submitted to the Committee for consideration.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the proposed roundabouts, and installation of regulatory signage and linemarking proposed at the intersection of Wuru Drive / Macquarie Drive and Macquarie Drive / Superior Avenue, Burrill Lake as detailed in the attached TRAF 2016/27, subject to items of a technical nature.**

---

**13. Timed Loading Zone - Meroo Street, Bomaderry (PN 3279)**

**File DA15/2090**

Council has been requested to consider installing a loading zone adjacent to the Bomaderry Hotel in Meroo Street, Bomaderry.

It is proposed to convert the existing No Stopping zone currently installed across the redundant driveway layback to 71 Meroo Street, and 6m of 1P parking adjacent to 69 Meroo Street into a loading zone timed 7am-12pm Mon-Fri.

It is also proposed to allocate 1 hour parking outside the loading zone times of operation (restricted 12pm-6pm Mon-Fri and 8.30am-1pm Sat) to limit the impact to parking.

Additional to this request, it has been identified that there is an opportunity to remove No Stopping restrictions adjacent to the existing pedestrian facilities in Meroo Street and increase available on-street parking, to offset the impact of the loading zone.

By relocating No stopping zones, an additional 2 parking spaces can be achieved at all times, and an additional parking space has also been created outside of the loading zone operation times (former No Stopping zone).

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to arrange for the following parking restriction amendments in Meroo Street, Bomaderry, as detailed in the attached plan TRAF 2016/28a & 28b:**

**a) on the western side of Meroo Street, south of the pedestrian facility adjacent to 71 Meroo Street, relocate the existing R5-400(R) No stopping sign 6m north of its existing location**

**b) on the western side of Meroo Street, north of the pedestrian facility adjacent to 71 Meroo Street, remove the existing No Stopping zone and install a Loading zone (time restricted to 7am-12pm Mon to Fri), combined with a 1P parking zone (time restricted to 12pm-6pm Mon to Fri, 8.30am-12.30pm Sat), for a distance of 14m (to the driveway between 69 and 67 Meroo Street)**

**c) on the eastern side of Meroo Street north of the pedestrian facility adjacent to 31 Meroo St, relocate the existing R5-400(R) No Stopping sign 6m south of its existing location.**

Following the installation of the No Stopping zone and bus zone on the northern side of Isa Road, Worrigeer adjacent to the Worrigeer Medical Centre, Council has been monitoring the effectiveness of these parking restrictions.

Council has received concerns from residents that when vehicles are parked on the northern side of Isa Road, west of the current No Stopping zone, the travel lane width is significantly reduced causing difficulty for two cars to pass one another.

In view of addressing the safety concerns raised associated with vehicles parking on both sides of Isa Road, Worrigeer, it is proposed to extend the existing No Stopping zone (8am-5.30pm MON-FRI) from its current location at the boundary of 45 and 47 Isa Road, to the boundary of 41 and 43 Isa Road (a distance of approx. 36m).

Consultation was carried out with affected property owners and residents.

One submission was received in support of the proposal.

**RECOMMENDED that the General Manager (Director Assets and Works) be requested to arrange for the extension of the existing No Stopping zone (8am-5.30pm MON-FRI) from its current location at the boundary of 45 and 47 Isa Road, Worrigeer to the boundary of 41 and 43 Isa Road, Worrigeer (a distance of approx. 36m) as detailed in the attached plan TRAF 2016/29.**

15. **Regulatory Signage and Linemarking Plan – 1 & 1A Beach Street, Huskisson (PN 3281)** **File DA07/1650-04**

Council has provided approval for the construction of a residential building comprising four levels of residential units (1 x 1 bedroom (managers residence), 3 x 2 bedroom and 10 x 3 bedroom), basement carpark for twenty-five (25) cars, three (3) above ground visitor car parking spaces, and five (5) car parking spaces within road reserve.

A signage and linemarking plan for the residential building has been submitted for the committee's consideration.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the installation of regulatory signage and linemarking proposed as part of construction of a residential building comprising four levels of residential units at 1 & 1A Beach St, Huskisson, as detailed in the attached plan TRAF 2016/30.**

16. **Linemarking and Signage Plan - Culburra Road, Wollumboola (PN 3282) File 53050E**

Council is undertaking road rehabilitation works on Culburra Road, east of Coonemia Road.

Regulatory signage and linemarking plans for Culburra Road have been submitted for the Committee's consideration.

The rehabilitation works include upgrading the existing linemarking at the intersection:

- extension of a C1 line across the intersection of Coonemia Rd
- Installation of an unbroken L3 lane line in the left turn lane on Culburra Rd
- Removal of the TB line across the southbound travel lane on Coonema Road.

**RECOMMENDED that the General Manager (Director Assets and Works) be advised that the Shoalhaven Traffic Committee has no objection to the installation of regulatory signage and linemarking proposed as part of the road rehabilitation project on Culburra Road, Wollumboola as detailed in the attached plan TRAF 2016/31.**
