2. Medical Centre, 51 Isa Road, Worrigee - Compliance with AS1428.1-2009 File DA15/1208

# SECTION MANAGER: Cathy Bern

#### **PURPOSE:**

On 1 December 2015, The Shoalhaven Access Advisory Committee resolved the following:

"The Committee were advised that The Medical Centre in Isa Road, Worrigee is expanding and that they have positioned the toilet in the middle of the wall, which is not compliant with AS1428 – Need to look at the DA"

In accordance with the above resolution the following report is provided to the Shoalhaven Access Advisory Committee for its information.

RECOMMENDED that the Access Advisory Committee receives this report for information.

#### **OPTIONS**

- 2. To reject the recommendation and provide an alternative recommendation.

#### **DETAILS**

#### DA15/1208 - Background

Development Application (DA) 15/1208 was approved by Council on 11 November 2015. The DA approved a change in use from a dwelling house to a medical centre at 51 Isa Road, Worrigee (see **Attachment 'A'**). The approved development comprising (summary only):

- Five (5) consultant rooms;
- Conference room (previously the garage);
- Waiting/reception area;
- Ancillary facilities including a staff toilet and accessible toilet;
- Treatment room:
- Isolation Room;

- Store room;
- Associated works including access/manoeuvring areas, drainage, etc; and
- Nine (9) car spaces (3 within the development site and 6 within Isa Road).

A plan showing the approved floor layout of the development is provided in **Attachment** 'B'.

# DA15/1208 - File Review/ Compliance with AS1428.1-2009

The floor plans originally submitted with the DA were amended as a result of concerns raised by Council officers that they did not comply with the provisions of AS1428.1-2009. Specifically, these concerns related to door widths, circulation areas and the accessible sanitary compartment.

The applicant subsequently submitted amended plans (see **Attachment 'B'**) with Council officers recognising that these contained insufficient detail for the accessible sanitary compartment. Council officers were however satisfied that the amended floor layout could easily be modified to demonstrate compliance with AS1428.1-2009 and as a result a condition was included in the development consent requiring compliance with AS1428.1 prior to the issue of a Construction Certificate (refer to Condition 17 of Development Consent 15/1208).

Council's Section Manager Building and Compliance has reviewed the development consent and is satisfied that Condition 17 of the issued development consent adequately addresses accessibility for a person with a disability.

A Construction Certificate (CC) relating to the approved development was issued by Council on 2 February 2016. A 1:20 floor plan of the accessible sanitary compartment was provided as part of the CC documentation (see **Attachment 'C'**). This has been reviewed by Council officers who have confirmed the toilet facilities design complies with AS1428.1-2009.

#### FINANCIAL IMPLICATIONS:

There are no direct financial implications for Council.

#### **COMMUNITY ENGAGEMENT:**

The DA when received was notified in accordance with Council's Community Consultation Policy. The issued development consent, associated approved plans and supporting documentation are viewable on Council's website using the DA Tracking links and the associated DA number.
