

Future Works Program

As stated throughout the Plan, a good community infrastructure network relies not only on the number of buildings or quantity of land for open space, but also includes the embellishments that support the activities that the community infrastructure is intended for.

From an open space perspective, Shoalhaven is over supplied in land for open space. The recreation and sports parks on this land, however, are under embellished and not meeting the standards prescribed in the desired standards of service (section 7.3.2 and Appendix F). As such, future works in the open space network are to focus on upgrading the recommended parks below to make the open space network compliant with all the desired standards (quantity, accessibility, land and embellishment (section 7.3.2)). To reduce the surplus of open space land, particularly recreation parks, a number of parks have been recommended for rationalisation or decommission.

Similar to the open space network, Shoalhaven is significantly over supplied with community buildings. Many of these buildings are single use and/or in poor or fair building condition. Over half (53.85%) of people that completed the community survey, indicated that they would travel 20 minutes or more to a high quality, multi-use community building. As such, future works for community buildings is to focus on rationalising single use buildings and using the funds to create community hubs with multi-use community buildings.

Recommendations to either upgrade, rationalise or decommission a particular community infrastructure were based on a number of key factors:

□ location

- is there better quality community infrastructure offering the same service near by
- surrounding environment (e.g. beaches, lakes)
- what is missing in the area
- *is there supporting community infrastructure nearby (e.g. a community building next to or within a sports park)*
- □ quality/condition of community infrastructure
 - are the embellishments/building ageing and nearing end of life
- □ usage rates
- $\hfill\square$ comments from community consultation.

Cost are based on the indicative costs provided in Appendix F.

I therefore strongly believe it is the time for some suitable high level recognition of him for this service and it should be in the near future as we are all aware of his developing health issues .



Dear Madam Mayor,

I am writing to inveigh how much I am against the naming of the auditorium of the Shoalhaven Entertainment centre 'The Greg Watson Auditorium'.

In 1982 Mr Watson perpetrated a most reprehensible, racist act against the Indigenous community of the Shoalhaven and the wider Australian Indigenous community, by burning the Aboriginal flag in a public display on Aboriginal Day 1982. Points on which I object to the naming of a public space after a man who committed a heinous act against people in our community are as follows,

- Council have an obligation to make public facilities/public spaces inclusive of all members of the community, if Shoalhaven Council name the auditorium after a man who has desecrated the Aboriginal flag they may be effectively excluding part of the community from that facility/public space.
- Council have an obligation to lead the community and uphold moral integrity, it must not reward acts of racism and aggression with awards of enduring honour, such as naming any building after someone who has blatantly perpetrated an immoral act.
- With the mission statement of Council's Community Strategic Plan (adopted June 2010) stating 'To enhance Shoalhaven's strong communities, natural, rural and built environments and appropriate economic activities through strategic leadership, good management, community engagement and innovative use of resources' the naming of the Auditorium after Mr Watson would be a poor act of leadership. It would also be far from good management, it would not enhance Shoalhaven's strong communities rather it could cause division and unease therefore this is in strict conflict with the mission statement and values of the Shoalhaven City Council. The person to be honoured through the naming of a public space or building must not be or have ever been engaged in, or even associated with, activities which are inconsistent with council's mission statements and values.

I feel there are many other people who are much more appropriate and who have contributed to our community with integrity and honour. I would sincerely hope that Shoalhaven City Council does not name the Auditorium or any other public space after Greg Watson given the most unfortunate circumstances of Aboriginal Day 1982, an act that whilst it never should be forgotten, neither should the perpetrator of it be honoured in any way.
