1. This membership entitles the holder to entry to all Shoalhaven Swim & Fitness facilities for the agreed term.
2. A minimum number of 5 memberships must be maintained at all times to be eligible for the Corporate Membership rate.
3. Membership suspension and refunds are not available.
4. If the applicant is between the ages of 16 and 18 years, a parent or guardian is required to sign the declaration.
5. All new members are entitled to a seven (7) day cooling off period.
6. A member agrees to abide by all dress regulation and code of conduct in the gym and fitness studios.
7. All members use the Centre at their own risk.
8. Shoalhaven Swim & Fitness (Shoalhaven City Council) is collecting personal information, including your photo, on your membership form to enable processing of enrolments and administration of your membership. This information will only be used by authorised Council staff. Supply of this information is voluntary however Council may not be able to process your application without it. You can apply for access and/or amendment of your personal information by contacting Council's Privacy Officer.
9. Monthly direct debit is deducted in advance from either bank account or credit card at the allocated time of each month. Three month minimum membership period required. Direct debit fees apply for late, dishonoured or fail payments.
