1 Introduction

The Shoalhaven Sports Board has been in place for many years and is operating based on a charter that was adopted in March 2000. Since that time there has been no formal review of the board, however there have been significant changes in governance requirements, sport and recreation trends and the manner in which councils engage with the community.

The purpose of this review is to provide recommendations for any improvements to the current Sports Board model which council uses to engage with the local sporting community in order that opportunities for the Council to better serve the sporting community may be realised.

During the review process trends in sport and recreation management and practices for community consultation have been assessed. In addition, surveys of stakeholders were conducted to gauge engagement and understanding of the current Sports Board and its functions. The scope of the Shoalhaven Sports Board Review included the following stages;

Benchmarking – Council Sporting Bodies. Benchmark the models used by comparable and neighbouring councils to liaise with the sporting community.

Review the Sports Board and the community consultative process. Review how the Sports Board operates in comparison to current community consultation models within Council.

Community Consultation and Feedback. Invite community feedback on how Council should consult with its sporting community.

Final Report and Recommendations.

Provide a written document which details the review process and proposes strategic directions. Present the Shoalhaven Sports Board Review findings to the Shoalhaven Sports Board.

This document completes the review, being the final report and recommendations.

Summary

In recent years there has been a groundswell in government planning which recognises the importance of sport with regards to not only the physical and mental health of the population, but also as an integral part of developing connected communities.

'In short, sport and physical activity not only make people healthier and more productive; they contribute to the nation's economic and social capital.'

Quote from: 'Sports funding: federal balancing act', Dr Rhonda Jolly, 27 June 2013.

In light of the following key factors;

- Recognition of the positive impact that participation in sport has on a community,
- Changing community expectations with respect to consultation and engagement and
- Changing sporting participation, volunteering and work pattern trends

the planning and management of sport is moving beyond the traditional maintenance of facilities. to goals which look to grow and enhance the grassroots of sport with multiple outcomes. Therefore, to strategically grow sport requires council to partner with the community to continue to foster increased participation.

Key findings of the review process are;

- The community is looking for clearer communication channels with Council.
- Broader representation of all sporting interests is required to strategically inform Council.
- Transparent and comprehensive processes and policies are needed.
- Greater advocacy and support from Council.
- Community Representatives who inform council need to be targeted based on skill sets.
- The responsibilities of councillors, community representatives and council officers which inform Council's strategic sports development are not clearly understood.

Based on these findings and investigation of the latest engagement models it is recommended that the current Sports Board process should be remodelled to meet the needs of the strategic sporting community and council.

The new structure proposed for the community to participate in strategically guiding sports development is an advisory board, which operates at a strategic level and is reported to by various sub-committees with responsibility for specific portfolios or projects. The advisory board would operate to a strategic plan and ensure actions are being conducted in accordance with that plan.

3 Review Results

3.1 Demographics of Shoalhaven LGA

Demographics and planning considerations specific to the Shoalhaven need to be considered in the strategic development of sport and in the main include;

- The dispersed village centred nature of the population.
- Projected population growth
- Tourism, both its impact on facility use and the opportunity to attract sporting events which in turn requires improved facilities.

3.2 Benchmark Analysis

During the benchmarking process literature related to the implementation of sporting strategies and community engagement processes was reviewed. In addition, discussions were undertaken with various LGA's and their sporting communities' representatives.

Following is a list of the councils from which data was received and analysed.

The findings indicate that;

- 1. The value of sport with regards to the physical and mental health of communities and its importance in contributing to community inclusiveness is increasingly being recognised and prioritised in council planning.
- 2. There is groundswell towards community engagement in the strategic planning of sport.
- 3. There are a variety of models used by councils to liaise with the sports community. The models which appear to be producing the best results include as priorities: strategic direction, clear communication, engagement, advocacy and encouragement of skill based leadership.
- 4. Given many lifestyle factors reducing participation in organised sport there is a growing need to partner with the community to continue to foster increased participation in sport.

3.2.1 Sport and Recreation Trends

Key societal changes are causing a shift in the way people engage in sport, communicate, work and therefore the structures required for councils to successfully engage with the sporting community are also changing. These changes include:

- 1. Changes in the workforce. More part time work and increased weekend work have shifted from the traditional 5-day work week, sport on Saturday and family on Sunday.
- 2. Single parent households and dual income families mean that recreation time is seen as a scarce resource.
- 3. Increased diversity in the availability of recreation alternatives, which may not have an organised operating structure means that sporting bodies are competing for attention.
- 4. Population growth.
- 5. Communication, social media and engagement tools.
- 6. Technology has impacted how sport is played and marketed.
- 7. Funding sources regularly change and require new skills and more time from volunteers.
- 8. Increasing governance requirements and sports management responsibilities.

Local government is also being pressured to manage and maintain existing infrastructure. and Development and ensure compliance to more stringent governance requirements for volunteers.

These changes have contributed to the following sporting landscape movements:

- Reduced commitment to teams or volunteering roles for a full season in the traditional sense.
- Growing demand for increased informal recreational activity options.
- Modified Rules. A number of traditional sports such as cricket, Rugby League, AFL and tennis have undergone modification to attract more participation.
- Volunteer Engagement. Local sports clubs experience difficulty in attracting new volunteers.
- Policies and grant funding criteria which reward multi use of facilities.
- Safety: Risk management implications regarding the quality of facilities and practices.
- Application of environmental sustainability development principles to public infrastructure is increasingly expected by the community.

In light of these changes the capacity of volunteers to consistently deliver sporting programs is being challenged. The diverse and changing nature of the sporting landscape requires real time engagement of council with the sporting community to enable good decision making and optimum utilisation of resources.

3.3 Sports Board and Stakeholder Consultation

Meetings were conducted with the Sports Board and stakeholders with the purpose of gaining an insight into the effectiveness of the existing Sports Board model. Feedback was received from councillors, council officers, Sports Board members and sporting association representatives.

The feedback, summarised in the table below includes some consistent themes, which suggest strongly that change is needed to meet engagement objectives.

3.4 Community Survey

An online survey and three local community meetings were conducted. In all 66 people responded to the online survey and 20 people attended the community meetings.

More than 50% of the community respondents were unaware of the sports board or their role. They felt a need for greater communication with respect to who to contact for their various needs. So, even if the current engagement model could help them they are unaware of it.

The engagement model needs to focus on big picture, strategic issues are the priority and not operational problems.

The community was concerned that the board only represented 'big' sports or big clubs. There is a need to provide real advocacy for all. This requires an intentional strategy to engage with the grass roots sports participants.

The capability of board members to fulfil their role was questioned. This was not aimed at individuals, rather a need to ensure skills are identified and sought.

A desire to support the growth of volunteers and club committees through training was expressed. Again, even if this support is available in any way the community is not aware of it.

Representation and engagement with all sporting communities & bodies was seen as lacking and needs to be planned.

Use of a marketing strategy and the means to encourage participation needs to be developed. Suggested examples included:

- Annual community forums
- A social media strategy
- Rewards in the Council grant application processes for clubs which attend volunteer training.

The roles of community delegates, council officers and councillors in the process was unclear to respondents and needs to be clarified and communicated.

4 Recommendations

It is most important to recognise the value of having a community representative role informing Council's sports strategic planning.

The most important factor in establishing an improved model for managing the sporting communities' engagement with council is to create a clear set of values and strategic priorities which align with the Shoalhaven Councils planning instruments.

It is apparent from considering the literature, models used by other councils and community feedback that the existing Sports Board Model needs to change. This report recommends a strategic focus, with a model for representation and the makeup of a new community advisory structure.

4.1 Strategic Focus

The big picture is strategic and not operational. Observations of the current board meeting and minutes, and feedback from the consultative process indicate that the existing Sports Board Model tends to get bogged down in operational matters. To alleviate this the new structure will need to be remodelled and run from a Strategic Plan. This plan will need to be aligned with the LGA community plan.

There was a strong sense in the community feedback that there is a need to increase advocacy for all sporting communities & bodies.

Benchmarks for Sport such as participation, growth and retention also need to be monitored.

4.2 Advisory Board Model

Based on this review Council has four possible options available for managing engagement with the sports community;

1. Continue with the Existing Sports Board Model.

This option is not recommended given the reasons outlined in this report.

2. Disband the board and mange engagement directly through council officers.

This option is not recommended as the community wants and needs community based advocates.

3. Implement a delegated authority management committee.

A management committee with authority over budget and sports ground management has worked well for some LGA's, however this is not recommended given that these committees seem to focus on the major sports and the Shoalhaven community feedback is requesting advocacy for all.

4. Implement a Skill Based Community Advisory Board.

The option recommended by this review is to implement an Advisory Board which is able to provide advocacy for the sporting community and advise council on policy and direction related to Councils strategic objectives.

The board would be strategic in nature and focus on skill based appointments.

The advisory committee would engage sub committees or interest groups to increase engagement and allow it to focus strategically, yet be well informed on specific situations.

More detail of how this model can be applied is included in Appendix I.

Appendix I: Advisory Board Details

1) Advisory Board Overview

Advisory committees or boards are generally made up of representatives from a particular profession, industry, peak-body, community or interest group who are <u>appointed to provide</u> <u>technical or specific information</u> on often complex or multi-faceted proposal(s) or issue(s). Establishing an advisory committee enables expert and ongoing input into planning and decision-making from a range of groups and agencies that have <u>relevant skills or knowledge</u>.

Advisory committee members have a mandate to provide ongoing, <u>high level policy and planning</u> advice to council.

Membership and terms of reference of the committee, including committee and participant roles and responsibilities, time frames and decision-making processes, need to be clearly articulated and agreed prior to commencement.

It is important to establish whether the committee members are representing a broader group or participating as individuals.


Strengths:

- values a wide range of technical and local expertise and knowledge
- provides committee members with an understanding of a range of perspectives, data sets and other knowledge bases in order to develop informed and agreed solutions.
- can support a range of other engagement processes.
- provides opportunities to explore alternative strategies and build on commonalities and alliances and enables information and decisions to be distributed to members of the organisations or community sectors represented on the committee.

Weaknesses:

- participants may not be representative of or have relevant knowledge or skills to represent all stakeholders.
- it can be difficult to manage the diversity of opinion, data, frameworks and other information provided via committee members and standing committees may lose impetus or relevance.

The board sets direction and policy. Actions or projects are allocated to working groups. Depending on the size of the activity the group can be large or small and may or may not include board members. The following diagram shows the relationship between the Advisory Board and working/focus groups.



In order to operate functionally and make consistent decisions the Advisory Board will need a good policy framework. This diagram shows an effective model.

- The leadership should always test what is said and done against the values, mission, and purpose.
- The terms of reference, policies, procedures and strategic plan are tools to deliver results.
- The strategy is map for future direction and can be used to review progress.

Values

Vision, Mission, Purpose

Defines your culture, who you are and what you exist for.



Terms of Reference

A contract between council and the committee. Defines governance, members and committee powers.



Policies & Procedures

Working documents which describe how things are done. Provide a system to ensure consistent ongoing results.



Strategic Plan

Integrated with LGA plan this plan will link vision to actions. Specifies 1-5 year goals, key area actions to achieve goals.

Plan > Do > Check > Act

2) Membership

To objective is to develop a skills based board and ensure inclusion in the membership of the board a range of strategic capability, expertise and advice. A possible membership could include;

Community Members: Six skill based members of the local community.

Councillors: Purpose – understand council processes speak to council meetings on behalf of the Advisory Board when proposals are put to council. With transparent policies in place ward based representation should not be needed on an advisory board, it is a waste of councillor resources.

Suggested membership. Council to nominate up to three Councillors to be on the Board.

Advisory Board member should have specific portfolios and report back to the committee on progress in their portfolios. These can be geographical, sport representation or project based.

3) Areas of Focus

The Advisory Board operates at a strategic level and other stakeholders interested is specific projects or areas of operation should work in the focus groups.

Following are example areas of focus that should include Sports priorities/future/benchmarks.

a) Governance

4) Terms of Reference

It is important that The Terms of Reference are established in conjunction with stakeholders. A number of example Terms of Reference documents are cited in the references and recommendations for inclusion are as follows;

a) Relationship to Council

The board is an advisory committee to council and as such makes proposals to council.

b) Delegated Authorities

The Committee does not have the power to bind the Council.

The Committee may make recommendations to the Council on all relevant business presented before it. Decisions made by the Advisory Committee are recommendations which may or may not be adopted by Council.

The Advisory Board does not have the power to incur expenditure, however Council may allocate a budget for specific projects.

Advisory Committee recommendations which are determined to be purely or substantially 'operational' in nature, will be dealt with by the relevant council officer and any action or lack thereof reported to the Committee on a regular basis.

c) Term of Office

Councillors appointed to a Committee shall continue as a member of the Committee until the next ordinary mayoral election.

Terms of office should be defined, with typical examples being 2-4 year periods of representation.

d) Nominations and Appointments

Nominations should be advertised throughout the community with specific skill based criteria applied to appointments.

A casual vacancy may be filled by the Committee.

e) Focus Groups

As deemed fit the board will establish focus groups to act in specific priority or project areas.

f) Meeting Practices and Procedures

The administrative provisions of Council's adopted Code of Meeting shall apply subject to any amendment by this Terms of Reference.

Each meeting shall be properly recorded by the taking of minutes.

The minutes of the Committee will be submitted to the next available Council Meeting.

The quorum for each meeting will be one half plus one of the number of Councillors nominated by Council to be on the Committee.

If a quorum is not present within 30 minutes of the time appointed for the commencement of the meeting, the meeting shall lapse.

In the event of a tied vote, the Chair can exercise a casting vote.

g) Code of Conduct

All members of the Committee are required to observe the provisions of the Council's Code of Conduct.

Committee members should act in a professional and responsible manner with the information they obtain as a Member as Committees require openness and honesty to function well. Committee members should feel free to express their opinions and views without fear of recrimination.

It is essential for committee members to accept collective responsibility, and remain loyal to decisions of the Committee, even where they may not have agreed with the final decision.

h) Confidentiality and Privacy

Members may have contact with confidential or personal information retained by Council. If so, members are required to maintain the security of any confidential or personal information and not access, use or remove any information, unless the member is authorised to do so.

Shoalhaven Sports Board Charter

1. Mission

The Shoalhaven Sports Board will work towards the development and advancement of sport in the City of Shoalhaven for the benefit of community well-being, health and fitness.

2. Aims and Objectives

The Aims and Objectives of the Shoalhaven Sports Board shall be to:

- 2.1 Formulate Policies on the development of Sport in the City of Shoalhaven and make suitable recommendations to Council as required in respect of:
 - 2.1.1 Facilitating communication between the sporting public and Council in order that the existing and future needs and requirements of those participating and those administering sports are accurately identified and brought to the attention of Council.
 - 2.1.2 Promoting the role and scope of sport and recreation to the Shoalhaven community.
 - 2.1.3 The need for additional sporting facilities in the City
 - 2.1.4 The priorities for the development of facilities in the City including both sport and recreation and to make suitable recommendations to Council.
 - 2.1.5 The priorities for Government Grants for sport and recreation facilities in the City.
 - 2.1.6 The setting of fees and charges for the use of Council sporting and recreational facilities.
 - 2.1.7 The setting of budgets for the administration of Sport within the City of Shoalhaven.
 - 2.1.8 Providing advice on the management of grounds.

3. Appointment

A committee of community representatives, the Regional Director of NSW Sport & Recreation and Councillors shall be appointed and shall be known as the Shoalhaven Sports Board.

There shall be 9 community representatives, nominated Councillors and the Mayor.

- 3.1 Councillors to be appointed for the term of the Council.
- 3.2 Community appointments to the Shoalhaven Sports Board be for a four year term, except in the first term when five of the community

representatives shall be appointed for four years and the remaining four shall be appointed for two years.

Thereafter appointments be for a four year term with half the Board retiring every second year. The Community representatives on the Board will be eligible for reappointment.

- 3.3 Positions on the Board be advertised every two years for appointment on a regular date. Self-nominations are normal and encouraged.
- 3.4 A panel be established consisting of the Mayor, the General Manager and the Executive Officer (Parks Manager) of the Shoalhaven Sports Board or their nominees to consider nominations for this Board and make appointments.
- 3.5 The panel to make its decisions considering such matters as:
 - 3.5.1 An ability to serve on Boards or Executive Committees where policy decisions are made
 - 3.5.2 Business acumen
 - 3.5.3 Leadership/entrepreneurial skills
 - 3.5.4 Interpersonal skills
 - 3.5.5 Standing in the Sporting Community
- 3.6 Where the above points have been considered then further consideration to be given to:
 - 3.6.1 Achieving a geographic spread throughout the City of Shoalhaven
 - 3.6.2 Achieving spread of sports interest amongst all sports in the City of Shoalhaven
 - 3.6.3 Spread of interest to be couched in broad terms such as ball sports, water sports, team sports, individual sports etc.

4. Meetings

Generally, the Board shall meet no less than six times per annum to consider the policy matters concerning the advancement of Sport in the City of Shoalhaven. The Board will set the times and places of the meetings, however they should be held on a regular basis wherever possible. The Shoalhaven Sports Board shall determine its own meeting procedures including time and place of meeting, particularly where it is proposed to meet with community representatives.

5. Quorum

A quorum shall consist of six members. In the event that a quorum does not exist within 30 minutes of the advised starting time, then the meeting shall be

abandoned and a new meeting called as soon as practical at the Chairperson's discretion. In the event that members leave a meeting, then that meeting shall be deemed closed should a quorum no longer exist.

6. Office Bearers

- 6.1 The Shoalhaven Sports Board shall, at its first meeting and then in that month of each year, elect from its own number a Chairman and a Deputy Chairman. At meetings, in the event of a tied vote then the Chairman shall have a casting vote as well as a deliberative vote. In the event that the Chairman is absent from the meeting then the Deputy Chairman shall assume the Chair. In the event that both are absent from a meeting, then a Chairman for that meeting shall be elected from the floor and that Chairman shall not have a casting vote.
- 6.2 Elections for Office Bearers shall be conducted by the Executive Officer.

7. Executive Officer

- 7.1 The Executive Officer of the Shoalhaven Sports Board shall be the General Manager or the General Manager's representative and will be an *ex-officio* member of the Board but is not entitled to vote.
- 7.2 The City Services Manager or the City Services Manager's representative, shall act in an advisory capacity.

8. Finance

- 8.1 The Board may authorise expenditure of funds within the sums voted for that purpose by Shoalhaven City Council, except as restricted by Section 377 (General power of the Council to delegate) of the Local Government Act.
- 8.2 The Board's financial year shall be from 1st July to 30th June each year.
- 8.3 The Executive Officer of the Board shall present financial statements to the Board at each of its meetings.

9. Promotion

9.1 The Shoalhaven Sports Board is charged with the advancement of sport in the City of Shoalhaven to maximise benefits to the people of Shoalhaven.

- 9.2 Recognising the need to give access to individual athletes and users, it shall address:
 - 9.2.1 The needs of individuals
 - 9.2.2 Athletes with disabilities
 - 9.2.3 Children in sport
 - 9.2.4 Athletes from culturally diverse backgrounds
 - 9.2.5 Athletes from Aboriginal backgrounds
 - 9.2.6 The role and requirements of volunteers in sports
 - 9.2.7 Sporting Clubs
 - 9.2.8 Associations of sporting clubs
 - 9.2.9 Sporting facilities (grounds, stadiums, tracks etc)
 - Current facilities
 - Maintenance of facilities
 - Preparation of facilities
 - Upgrading of facilities
 - Construction of new facilities
 - Policies with respect to facilities including fees.
 - 9.2.10 Administration of Sports Grant programs
 - 9.2.11 Co-ordination of sporting events with a view to maximising the prestige and economic vitality of the City of Shoalhaven
 - 9.2.13 Assistance to Clubs and Associations to attract "Events of Significance"
 - 9.2.14 Strategic plans for sporting fields and facilities
 - 9.2.15 Securing sponsorship
 - 9.2.16 Maximising the health and fitness benefits to the people of Shoalhaven
 - 9.2.17 Any other issues that may arise

10. Private Enterprise

10.1 Declaration of Interest – Committee Members should take note of the requirements concerning conflict of Interest and Disclosure guidelines. Shoalhaven City Council's Management Committee guidelines, section 4.4 – Conflict of Interest, refers to relevant sections of the Local Government Act and these are attached at Appendix A.

10.2 The Shoalhaven Sports Board will encourage patrons, benefactors and/or sponsorship of sports and events as appropriate.

11. Reporting

The Shoalhaven Sports Board shall submit Minutes of its meetings and shall submit reports to the quarterly reporting and annual reporting Management Plans of Shoalhaven City Council.

12. Corporate Plans

The Shoalhaven Sports Board will take into account goals detailed within the City Plan, the Recreation Strategy and the Community Plan and will implement or cause to be implemented, those goals, as resources permit.

13. Directions from Council

From time to time, Shoalhaven City Council may place directions or requests before the Shoalhaven Sports Board.

14. Reports

The Shoalhaven Sports Board shall produce an annual report, by way of a "Year in Review", which assesses:

- 14.1 The involvement of Shoalhaven people in all sports
- 14.2 The availability of sporting facilities to the people of Shoalhaven
- 14.3 The achievement of excellence in sport in the Shoalhaven
- 14.4 The development of individual sports
- 14.5 The role of sport in the development of community
- 14.6 Those sporting events of regional, state, national and international status that were held in the Shoalhaven
- 14.7 Shoalhaven individuals and teams that competed in regional, state, national and international events and the results of those competitions

15. Advisory Role

The Shoalhaven Sports Board may fulfil the functions of an advisory body to Shoalhaven City Council on:

15.1 Any matter relating to Sports

- 15.2 Sporting Developments that are required in the City of Shoalhaven to expand existing infrastructure and thereby make the Shoalhaven more attractive to a greater number of people
- 15.3 Upon request either by Shoalhaven City Council, or by officers of Shoalhaven City Council, as to the suitability of specific projects within the Shoalhaven. These may be as a result of development applications lodged or as suggestions from various sectors of the community

16. Other Bodies

- 16.1 The Shoalhaven Sports Board shall necessarily interact with other sports bodies throughout the State and throughout Australia. These shall include:
 - 16.1.1 New South Wales Sport and Recreation
- 16.2 Close liaison should be maintained between the Shoalhaven Sports Board and New South Wales Sport and Recreation.
 - 16.2.1 Commonwealth Department of Sport
 - 16.2.2 Australian Institute of Sport
 - 16.2.3 Other Bodies
- 16.3 The Shoalhaven Sports Board will maintain liaison with other sports bodies such as State and National Sporting Associations.

17. Sporting Representation

- 17.1 The Shoalhaven Sports Board shall support sporting associations within the Shoalhaven and encourage the establishment of effective local sporting associations.
- 17.2 Local sporting organisations should be encouraged to ensure that City identifiers are encompassed within their sport.

18. Awards and Recognition

The Shoalhaven Sports Board will review sports achievement and recognition as part of its general role.

19. Revision of Charter

In view of the delegation of Council powers to the Shoalhaven Sports Board, in the event that the Shoalhaven Sports Board wishes to revise this charter, then it shall so advise the Council and seek the ratification of Council on those revisions. Council may revise this charter at any time and in any way it sees fit.

1. PURPOSE

The Sport Community Advisory Group (Group) is to provide advocacy for the sporting community on policy and direction related to Council's strategic objectives. To achieve this policy and strategic objective, the Group will be strategic in nature and focus on skill based appointments to achieve this outcome.

2. STATEMENT

Council encourages and recognises the value of community participation in guiding the strategic development of both sport facilities and participation within the Shoalhaven Local Government Area. To guide sports development each Group member will be responsible for maintaining and reporting on a specific portfolio.

3. TERMS OF REFERENCE

3.1. RELATIONSHIP TO COUNCIL

The Sport Community Advisory Group is a Strategic Advisory Committee (Group) to advocate for and inform Council's decision making processes related to improving Shoalhaven sporting facilities and sports participation.

3.2. ROLE OF THE SPORTS COMMUNITY ADVISORY GROUP

- Represent the whole Shoalhaven Sporting Community (all sports)
- Provide ongoing, high level policy and planning advice to Council.
- Make recommendations to the Council on all relevant business presented before it
- Advocate and maintain specific sports related portfolios.
- Advocate and promote Group recommendations.

3.3. MEMBERSHIP

Group membership is to be skill based with a range of strategic capability, expertise and advice to cover specific sports related portfolios.

The Group will have a total membership of nine (9) positions which include:

- Six (6) skill based local community members.
- Three (3) Councillors be nominated by the elected Council.

In addition a member of NSW Sport & Recreation will be invited to attend Group meetings but will have no voting privilege.

3.4. COMMUNITY MEMBER APPOINTMENTS

- Nominations should be advertised throughout the community with specific skill based criteria sort for appointment.
- Appointment to the Group can be for a maximum four (4) years with a set commencement and finish date.
- Vacancies will be advertised locally via media and Council communication networks.
- Council will manage the application process.
- An interview panel will consist of a Council staff member and one (1) suitably qualified independent representative to assess the applications and make recommendations for appointments to the Group.

3.5. TERM OF OFFICE

- Community membership will be renewed every 4 years and ideally during the midterm of the elected Council.
- Councillor membership will be renewed at following normal Council elections.
- Should there be a casual Community membership vacancy it may be filled upon the resignation of a Community member and will align with set fixed finish dates.

3.6. GROUP MEMBERSHIP WITH SPECIFIC PORTFOLIOS

All Group members will have specific portfolios which cover the following areas of focus:

Sporting Governance

- Sports Association liaison
- Sports Management Training
- Marketing & Advertising
- Induction for members
- Governance
- Strategic planning
- Stakeholders

Communication and Marketing

- Systems & Processes;
- How to interact with Council links with:
 - Grass roots sports
 - Elite sports
 - Peak sporting bodies
 - o Indigenous sports
- sports tourism

Grass Roots Club Development

- Volunteers educated/supported
- Volunteer Succession Planning
- Evaluate programs

Grants and Funding

Identify grant and other funding opportunities

 Assist with preparation of funding submissions working with Council staff and other stakeholders

Sports Tourism, Programs and Events

- Advocate for sports tourism opportunities
- Represent Sports Community Advisory Group at programs and events

Facility Development

- Ensure consistent with adopted Council Policies / position
- Alignment with strategic direction

Talent Programs

 Linkages, facilitation and liaison between grass root sport clubs / organisations and elite training programs / opportunities

3.7. MEETING PRACTICES AND PROCEDURES

- The administrative provisions of Council's adopted Code of Meeting shall apply subject to any amendment by this Terms of Reference.
- A Councillor nominated by the elected Council to be on the Group will be nominated by Group members to chair meetings.
- Each Group meeting shall be properly recorded by the taking of minutes by Governance Unit.
- The minutes of the Group meeting will be submitted to the next available Council Meeting.
- The quorum for each meeting will be five (5) members of the Group.
- If a quorum is not present within 30 minutes of the time appointed for the commencement of the Group meeting, the meeting shall lapse.
- In the event of a tied vote, the Chair can exercise a casting vote.
- Formal Group meetings will be held quarterly.
- Agenda and minutes from previous Group meetings will be circulated to members at least seven (7) days prior to the meeting.
- Group members must declare in writing any interest in any report tabled at the meeting covered by the Code of Conduct and Pecuniary Interest.
- Informal Group meetings, special meetings that may discuss specific portfolio matters will be held as and when required or set by the Group
- Planning and costs associated with conducting meetings will be borne by Council.
- Group recommendations which are determined to be purely or substantially 'operational' in nature, will be dealt with by the relevant council officer and any action or lack thereof reported to the Group.

3.8. CODE OF CONDUCT

- All members of the Group are required to observe the provisions of the Council's Code of Conduct.
- Group members should act in a professional and responsible manner with the information they obtain as a member, as the Group require openness and honesty to function well.
- Group members should feel free to express their opinions and views without fear of recrimination.
- It is essential for Group members to accept collective responsibility, and remain loyal to decisions of the Group, even where they may not have agreed with the final decision.

3.9. CONFIDENTIALITY AND PRIVACY

Members may have contact with confidential or personal information retained by Council. If so, members are required to maintain the security of any confidential or personal information and not access, use or remove any information, unless the member is authorised to do so.

3.10. COMMUNICATION

- Members of the Group are not permitted to speak to the media as Committee of Council representatives of the Group unless approved by the Chairperson.
- Where approval has been given by the Chairperson, views and opinions expressed are those of the Group and not of Shoalhaven City Council.
- Where endorsement is required from Shoalhaven City Council, approval must be sought through the formal processes.
- The Chair of the Group is the point of contact for communication between Group members and Council staff.

3.11. COUNCIL STAFF ATTENDANCE

Executive Council staff are normally required to attend the meetings of the Group. Other staff at the relevant Group Directors' discretion or at the Group's request can attend meetings as required. Staff have no voting privileges.

Council will provide secretarial support to arrange meetings and take minutes and provide professional office support where required.

3.12. EXPECTATIONS OF GROUP MEMBERS

- Group members will undertake the prescribed Induction process.
- Pecuniary Interest Returns are required on appointment and annually as required by the Office of Local Government and Council.

3.13. RESPONSIBILITY OF COUNCIL

 Council at its discretion may review and change the Terms of Reference, Role and Structure of the Group.
