Examples of how local businesses have used the \$500 Safety Rebate:

- A window and gutter cleaning business from Nowra received \$480 for a ladder and fall arrest system to work safely at height.
- A refrigeration and aircon sales business in Wollongong received \$500 for racking, safety barriers, signage and a trolley to help prevent falls on the same level.
- A café in Wollongong received \$252 for ergonomic office furniture to prevent muscular stress.
- An electrical business in Kiama received \$500 (out of pocket \$320) for double sided ladders to work safely at height.

2019 SILICA SYMPOSIUM

SafeWork is hosting a one-day conference covering all things silica dust in Sydney on 7 May and is an opportunity for businesses to learn how industry leaders are tackling the issue.

The event is tailored to business owners, managers, workplace health and safety (WHS) representatives and workers from all industries that deal with potentially deadly silica dust found in manufactured and natural stone, concrete, brick, tile and clay.

The symposium is an opportunity to network and learn how leading businesses are tackling the issue as well as hearing from experts across health, occupational hygiene and WHS.

They will also receive information on the government services available to support them to protect the health of their workers.

Eligible businesses will qualify for a \$500 small business rebate to put towards safety solutions in their workplace.

SAFEWORK UPDATES

FORMALDEHYDE – A PRIORITY CHEMICAL

Formaldehyde is a colourless, irritating and unpleasant smelling flammable gas. It is soluble in water and often used as water based solution known as formalin.

The NSW Work health and safety roadmap has a target of a 30 per cent reduction in serious injuries and illnesses by 2022, which comprises a reduction in exposures to hazardous chemicals and materials. A priority list of 100 chemicals, based on national and international research was developed, in which ranked formaldehyde first.

LPG CYLINDERS SHOULD NOT BE STORED OR USED INSIDE COMMERCIAL KITCHENS (REVISED OCTOBER 2018)

This safety alert advises NSW workplaces not to store or use portable LPG gas cylinders inside commercial kitchens. It is dangerous and illegal to use LPG gas appliances designed for 'outdoor use only', indoors. It puts workers and others at risk of fire, explosion and asphyxia, especially in commercial kitchens. Work carried out on any gas installations by a person without the appropriate licence, training and experience also puts workers and others at risk of serious injury from fire and explosion.

BACKGROUND

SafeWork NSW has responded to several serious incidents at the workplace involving gas, which ignited and led to serious burn injuries. Whilst SafeWork NSW has focused its compliance programs on the inappropriate use of gas appliances connected to portable LPG cylinders indoors the latest incidents relate to work being carried out on fixed gas installations by unlicensed persons.

STEEL WIRE ROPES IN MARINE ENVIRONMENTS

This safety alert reminds people of the risks associated with working with wire ropes and chains in marine environments, and the actions requires to ensure those risks are eliminated or minimised.

BACKGROUND

In 2017 an incident occurred when a luffing rope failed on a 210 tonne barge mounted crane failed causing the crane jib to collapse into Sydney harbour.

In January 2018, a main hoist rope failed on a boat hoist at a marina at Newport.

In February 2018, an incident occurred when a trolley rope failed on a portainer crane at Port Botany

In 2018 a further two trolley steel wire ropes and a hoist rope have failed on portainer cranes at Port Botany.

These incidents demonstrate the hazards associated with steel wire ropes in maritime and other adverse environments

INCIDENT INFORMATION RELEASES

FALL THROUGH VOID 17 NOVEMBER 2018

A worker has fallen from the first floor of a residential construction site through a stair void and suffered fatal injuries.

Location - Green Valley

INCIDENT OVERVIEW

A 29-year-old male air conditioning mechanic fell from the first floor of a residential construction site through a stair void. The worker suffered fatal head and neck injuries.

THE INVESTIGATION

SafeWork NSW Inspectors responded to the incident.

SafeWork NSW has commenced an investigation to determine the cause and circumstances of the incident.
