

The End of Term Report provides an update to the Shoalhaven community on the progress towards achieving the social, environmental, economic and civic leadership objectives of the Community Strategic Plan – Shoalhaven 2027.

The report provides comments about the actions undertaken as part of our Delivery Program and Operational Plans within the Council term 2017 to 2021.

The report highlights what we consider to be the significant achievements, as well as any key challenges and pressures in meeting the goals set within this term. The report follows the four themes and ten priority areas of the Community Strategic Plan.

Each section provides a priority statement that outlines the desired outcome set at the start of the Council term, with commentary and a table that shows if the goals set for each focus area were achieved.

### **Highlighted Council Achievements**

- Launched media campaign in partnership with Illawarra-Shoalhaven councils for visitors to stay COVID-19 safe over the Summer holidays
- Sussex Inlet Streetscape upgrade \$500K
- Shoalhaven Riverfront Masterplan Finalised

- Completed Artie Smith Oval concept designs for Croquet, AFL and Cricket, commencing delivery phase
- Bomaderry Affordable Housing Project
- CCTV and lighting installed at Nowra Wharf and Riverfront, to be reinstalled at the completion of the Nowra Bridge
- Award winning Bushfire Recovery Plan including the support hotline, wildlife feeding and on-ground repair of damage to critical infrastructure
- Commencing Recovery into Resilience Action Plan with \$2M Federal and NSW Government Funding
- Opening of the Learn to Ride facility at Parramatta Park
- Awarded \$8M in funding Federal & State Government for the Artie Smith development at the Shoalhaven Community and Recreational Precinct (SCaRP)








#### Council Facility Usage -**Aquatics & Leisure Centres**



### Highlighted Council Achievements

- Better boating improvements with three new boating facilities in Huskisson and Woollamia opened
- 681 illegal dumping incidents investigated by Council officers
- Finished the Callala Creek Wetland Walk funded through NSW Local Land Services and supported by Council's Bushcare program
- Completion of the Reclaimed Water Management Scheme (Stage 1B)
- Sustainable Energy Policy adopted with target of net-zero greenhouse gas emissions by 2050
- Won the national Cities Power Partnership 2020 Climate Awards in the 'Energy Efficiency' category
- Commissioned Council's largest solar PV array (96 kW or 270 solar panels) at Vincentia Wastewater Treatment Plant
- Adopt a Road Program launched
- Implementing priority actions from the 2018 Coastal Zone Management Plan and reestablishing Coastal Management Committees

### Highlighted Council Achievements

- New Nowra CBD Planning Controls were adopted, including detailed building heights and supporting urban design provisions
- Great success of campaigns 'Rejuvenate' (post bushfire) and 'Spend Here This Year' resulting in a \$53M reach in publicity
- Improvements at Holiday Haven Tourist Parks including a new pool at Lake Tabourie, new cabins at Ulladulla and Huskisson and new camp kitchens at Bendalong and Huskisson
- Works were completed for Woollamia Stage 5 Industrial Estate yielding 11 new lots in 2019
- In 2018, delivered the Unspoilt Campaign and launched the new tourism website Shoalhaven.com
- Strong demand following COVID-19 related border closures with Holiday Haven Parks achieving large increases in site and cabin occupancy
- \$4.5M grant approved for expansion of the Albatross Aviation Technology Park to create up to nine industrial lots that support the Defence industries

- Sustainable Tourism Infrastructure Project at Ray Brooks Reserve, Palm Beach completed including a carpark upgrade, accessible parking, shared paths, picnic shelters and BBQ
- Focus on the revitalisation of the Nowra CBD through development of a new Retail Strategy and historic walk
- Hosted a screening of a new Aboriginal-themed film called 'The Flood' filmed in Kangaroo Valley with 70 local Aboriginal community members attending
- Holiday Haven Central Reservation Call Centre trial commenced to achieve booking uplift at holiday parks
- Economic Development Office has established an Export Hub to help Shoalhaven businesses take advantage of export opportunities
- Delivering business recovery sessions offering advice and linkages to funding support following impact of the 2019-20 bushfires
- Further improvements to the Woollamia Boat Launching Ramp opened in 2021 including a new car park, pontoons, ramp enhancement, revetment works and maintenance area

### Why is this priority important?







#### Unrestricted current ratio




Debt Service cover ratio


