Moth Vine	М	Hand pull if small or cut & paint
Madeira Vine	M	By hand by digging up tubers or herbicide during warmer months
Fishbone fern	H	Keep to a limit by hand if small, digging
Camphor laurel saplings	M	Hand pull or lopped and cut & paint
Monstera	M	Keep to a limit by digging out new plants
Asparagus fern	L	Hand pull when soil is moist by removing entire root system
Cocos palm	L	Manually cut trunk just below the lowest leaf. Hand pull small seedlings
