


#### **CMP** Consultation

Throughout Stage 2 of the Sussex Inlet, St Georges Basin, Swan Lake and Berrara Creek Coastal Management Programs (CMP), the local community has identified key issues and ideas to be included in the CMP. Two community workshops were held in March 2022, one in Erowal Bay focussing on St Georges Basin, and the other at Sussex Inlet focussing on Sussex Inlet, Swan Lake and Berrara Creek. As well as the workshops, an online survey using the "Place Tool" platform was undertaken between March and May 2022, where community members were able to pin locations of key management issues and provide suggested actions.

The Sussex Inlet, St Georges Basin, Swan Lake and Berrara Creek Coastal Management Programs (CMP) are now progressing through to Stage 3. In this stage, our project team has developed a list of potential management actions for consideration in each CMP.

This Factsheet summarises what the project team have heard from the community, and how these issues have been considered in formulating potential management actions for the CMP.




#### What potential management actions can we include in the CMP?

Key issues and opportunities based on feedback from the community workshops have been summarised in the tables below. These issues and opportunities identified by the community, together with issues and opportunities identified by responsible Agencies, through detailed studies undertaken for the CMP, and a detailed Risk Assessment, have helped us formulate draft potential management actions to include in the CMP. Actions included have been highlighted in green, actions covered elsewhere in yellow and actions that we have not included in red, with comments on each.

#### What we have heard so far

Over 120 suggestions and issues have been received from the community during Stage 2 of the CMP. These suggestions have been incorporated into the list of Potential Management Actions.


