About this Report

Requirements as per Act (section 428) Shoalhaven City Council 2018-19 Annual Community Report was produced to comply with the Local Government Act 1993 (section 428) and the Local Government (General) Regulation 2005 (clauses 132, 217 and 224). Details of **Overseas Visits**

Local Government (General Regulation 2005 – Section 217 Clause 1(a)

On 24 June 2018 Council resolved that:

Site visits be carried out to facilities with relevant technologies including but not limited to Eastern Creek and Poland (including Germany if required), by at least 2 members of the tender evaluation panel and 2 Councillors (Clr Wells and Clr Pakes with an alternate being Clr White) and this be deemed as Council business.

In accordance with the resolution. Councillors John Wells and Mitchell Pakes, together with the Director of Assets and Works (Mr Paul Keech) and Council's Waste Services Manager (Mr David Hojem), undertook overseas travel between 6 August 2018 and 14 August 2018.

This trip included industry visits and meetings in to Rozanski, Ilawa, Grodziczno, Elbag, Olszytn, Lubelska and Warsaw in Poland, and Rüdersdorf and Berlin in Germany. The assessment of each facility was based on the original tender assessment criteria (value for money; achievement of objectives; experience and expertise; capacity and capability; management), but more specifically:

- Validity of the claims (is the process functioning as described?);
- Quality (contamination or purity) of the output products;
- Minimisation of environmental effects (odour, noise, litter, dust, emissions);
- Evidence of sound management, management team history, systems, management style as reflected on the workshop floor, maintenance and openness to new and innovative opportunities;
- Significance of WHS in the facility;
- Industrial relations and staff management;
- Reputation with suppliers of waste material, receivers of sorted/recycled products and with regulatory agencies.

The total expenses incurred by Council for the four-member panel was \$22,353.

Water Services

During 2018/19 Shoalhaven City Council participated as a member of the NSW Water Directorate, member of the Water Services Association of Australia (WSAA), and as a corporate member of the Australian Water Association (AWA) and Water Aid Australia.

Illawarra Shoalhaven Joint Organisation

The Illawarra Shoalhaven Joint Organisation (ISJO) is a partnership between Wollongong City Council, Shellharbour City Council, Kiama Municipal Council and Shoalhaven City Council. ISJO provides a framework for member councils to work together in collaboration with the NSW Government to deliver services for the communities of the Illawarra Shoalhaven.

Local Government Internal Auditors Network (LGIAN)

Involves Internal Auditors from various Councils in NSW as well as other professional bodies.

Local Heritage Assistance Fund

Council's Heritage Advisory Service and Heritage

Strategy are collaborative partnerships with the NSW Government Office of Environment and Heritage to promote cultural heritage in the Shoalhaven. The Heritage Strategy is prepared on a triennial basis and milestones are submitted to the NSW Government through its annual report. Council also runs the Shoalhaven Local Heritage Assistance Fund to assist owners of heritage listed properties and community groups with basic repairs, conservation works and small education and interpretation projects.

NSW Health

Shoalhaven City Council Environmental Health Officers are part of the Illawarra Shoalhaven Local Health District and Local Government Liaison Group. Under the Public Health Act mandatory reporting of notices issued by Council is required to be provided to NSW Ministry of Health.

2018/19 - 14 Improvement Notices were issued on public swimming pools.

NSW Food Authority

Council is part of the NSW Food Regulation Partnership which with other local government areas and the NSW Food Authority work together towards safer food. Council's Environmental Health Officers are part of the Illawarra Regional Food Surveillance Group.

Various Schools

Several primary schools benefited from Council staff delivering modules on sustainability, planning and environmental management. Examples include:

- Mentoring students weekly from Vincentia High School
- Tree planting with St Georges Basin Primary
- Threatened Species Day competition for all Shoalhaven primary schools.

Environmental Services also ran educational sessions for students from Trinity Grammar at their new field station in Woollamia. The students learnt about water quality, threatened species and endangered ecological communities.

Threatened Species Day Competition

Council ran its annual Threatened Species Day Competition with primary schools across the City. The aim of this initiative is to raise awareness of the plight of threatened species. Over \$600 worth of prizes go to local schools as part of this educational initiative. The artwork was displayed in Councils foyer for the month of September to promote community awareness.

Managing Environmental Change through Planning for Transformative Pathways.

In partnership with Griffith University and Wollongong University, Council supported a series of workshops with members of Council's Natural Resource and Floodplain Management Committee and Sustainable Futures Committee, Councilors and Council staff.

National Tree Day

Council staff organised tree plantings with students from Shoalhaven High School at Yellow Bellied Glider Reserve, Sanctuary Point. Also, various Bushcare groups organised plantings at Jerry Bailey Reserve at Shoalhaven Heads, Dolphin Point, Wrights Beach and Broughton Vale.

South Coast Cooperative Libraries

The South Coast Cooperative Libraries is a co-operative comprising the two local government areas of Shoalhaven and Kiama. Kiama outsource most of the purchasing, cataloguing and processing of their book and non-book materials to Shoalhaven. The primary role of the Cooperative Libraries is to set budget estimates for the partner book and non-book resources, develop mutually beneficial partnerships and to apply for joint grants where appropriate

Workforce Diversity

Local Government (General) Regulation 2005 - Section 217 Clause 1 (a9)

Council is committed to developing an equitable and diverse workforce which is representative of our community and the region. More importantly, Council aims to provide a working environment where all employees are welcomed, valued and differences are respected.

In Council's Workforce Plan for 2017 – 2021 strategies have been identified to ensure Council's recruitment processes deliver a diverse workforce that is representative of the community and achieve the objectives of Council's Disability Inclusion Plan including developing partnerships with community organisations to achieve the outcomes. Implementation of an electronic recruitment system enables the capture of data in relation to disability, age and ethnic background.

Council's offering of flexible work programmes including flexible work arrangements, transition to retirement, rostered days off and variable working hours support further the ability of staff to maintain a work / life balance. Council continues its partnership with Hunter Valley Training Corporation hosting an increasing number of trainees in civil construction, water operations and administration and Council continues to provide work experience opportunities for high school students and internship opportunities to students studying in various disciplines at Universities across NSW.

The overall percentage of women in the SCC workforce is 37.5%. Shoalhaven City Council has an ageing workforce, with 46% of staff aged 50 or Older, 25% of whom hold management/supervisory roles. Further, 3% are retirement ready (65+), 24% of these employees hold management/supervisor roles; 10% will be eligible to retire within the next 5 years (60+), with 19.6% in manager/supervisor roles. This contrasts to only 14.7% of workers aged 30 and under.

Council has in place an established traineeship and apprenticeship program to assist in attracting and retaining young people within the organisation through an agreement with a third-party provider with on average 65 participants involved. These externally engaged trainees are not included within the numbers below. Council has also identified additional strategies within its Workforce Plan 2017 – 2021 to address the ageing workforce challenge.

Senior Staff Remuneration Package

Shoalhaven City Council is a multi-purpose Council administering traditional local government activities as well as other major activities such as the provision of water and sewerage services, tourism and industrial development.

The total assets of the City is around \$3 billion which would place the City, in asset value terms, among the top 10 percent of organisations within Australia.

Council's expenditure (including depreciation) is over \$245 million dollars per annum which includes Council's commercial activities.

Council employs over 1000 staff on a full-time equivalent basis including casual/temporary/fixed term staff as required.

Council administers approximately 99 Acts of Parliament and associated regulations and needs professional staff that have a wide-ranging

Council's activities link strongly to other Government agencies, particularly at the State level, which requires sensitive handling where State Government changes the political emphasis from time to time.

The total amount of money payable for salary, fringe benefits, vehicle and other on-costs for Council's senior staff, including the General Manager and four Group Directors, in 2018/19 is summarised as follows:

- General Manager \$364,584 p.a.
- Acting General Manager \$106,652 (15 wks)
- · Combined Directors \$990,124 pa

Companion Animals Act

Statement of activities relating to enforcing and ensuring compliance with the Companion Animals Act and Regulation including information on:

Lodgement of Pound data collection returns with the department

The information contained in this section of the Annual Report is reported to the Office of Local Government (OLG) in accordance with their guidelines.

Lodgement of Data relating to dog attacks with the department

Dog Attacks reported to OLG via OLG reporting system as incidents occurred. During the reporting period there were 221 dog attacks reported to the OLG within by Shoalhaven City Council (SCC). Only dog attacks reported to Council are included in this figure.

Amount of funding spent relating to companion animal management activities.

Shoalhaven City Council has spent a total of \$1,502,539 in respect of companion animal management and related activities during the reporting period.

Companion animal community education programs carried out.

Rangers Services have strived to raise community education on companion animals' rules and regulations through Council generated media content. From July 2018-July 2019 six media releases were created and distributed in collaboration with Council's communications team. Each of these resulted in media interviews and social media posts on Council platforms as well as publication in local news outlets in the Shoalhaven.

Topics included responsible pet ownership, registration, changing in rules in NSW registration and community awareness regarding dog on dog attacks in the community. Rangers Services assisted with more than 10 media enquiries during this financial year that included enquires

on responsible pet ownership in the Shoalhaven.

Rangers staff were also involved in Council Information Nights during May 2019 where the community were given the opportunity to ask Rangers services questions during drop in sessions. These were in Nowra, Ulladulla, Berry and Culburra NSW.

Strategies Council has in place to promote and assist the desexing of dogs and cats.

Councils Animal Shelter is now managed solely by Ranger services since the withdrawal of RSPCA in 2018. Shoalhaven Animal Shelter promotes the desexing of dogs and cats in conjunction with the Animal Welfare League. A monthly "Chip and Snip" day is held at the animal shelter on the second Sunday of each month, this aids with Microchipping and discounted desexing Vouchers.

Shoalhaven Animal Shelter also promotes National Desexing month in conjunction with local Veterinary Clinics who provide discounted desexing. The goal is to end pet overpopulation by making desexing available and more affordable to pet owners who need it most.

Shoalhaven Animal Shelter has created a Facebook page with over 7000 followers. Council uses this page to promote the above strategies along with the weekly "Did you know" post which shares information about responsible pet ownership in the Shoalhaven.

Strategies to comply with Section 64 (Companion Animals Act) to seek alternatives to euthanasia for unclaimed animals.

Shoalhaven City Council has managed its Animal Shelter since June 2018. During this time the Shelter has a zero-euthanasia rate of healthy adoptable animals. Council has achieved this rate by adopting the following for its shelter residents:

- Transfer to breed specific rescue.
- Transfer to rescues that specialise in older dogs/cats that may require much medical

treatment

- Weekly training from dog trainer to work on small issues that could complicate and adoption.
- Decrease in adoption fees for older dogs and cats and decreased fees for long term residents.

Shoalhaven Animal Shelter is embarking on a program to work with other Council managed Shelters in NSW to cross transfer long term residents who may have a higher chance of adoption in another LGA.

Off-Leash Areas provided in the Council area.

SCC understands that it is necessary for our communities' dog owners to have access to suitable exercise and play facilities. The Access Area for Dogs Policy is developed by the Social and Infrastructure Planning Unit in consultation with the community and government agencies. Council undertook an extensive review of the

policy in 2012/13 to develop more consistent and user-friendly signage. This policy is currently being rolled out across the LGA and the policy became effective 17 February 2015.

During the operational period of the Policy, Council staff document all community correspondence include complaints and requests, this information will inform the next policy review. Council trialled a restricted timed off leash area at Narrawallee Beach which has now been implemented. Council's policy is available by contacting Council's customer service line or via Council's website.

Where applicable, signs are posted indicating off leash times and areas. For all remaining public areas where dogs are available to access, they must be on leash at all times.

Public Interest Disclosures

Act 1994

The Public Interest Disclosures Act, 1994 (PID Act) requires that Council report annually on its obligations under the Act. This report is made in accordance with Sections 31 and 6E of the PID Act, and Clause 4 of the associated regulations.

The PID Act encourages and facilitates the disclosure, by public officials, of:

- Corrupt conduct
- Maladministration
- Serious and substantial waste of public money
- A breach of the Government Information (Public Access) Act, 2009
- A breach of pecuniary interest obligations under the Local Government Act, 1993.

The Act sets out a comprehensive framework for protecting public officials who disclose wrongdoing and provides clear pathways for those wanting to make disclosures.

Council's internal reporting policy contains the procedures relating to the lodgment, receipt, assessment and handling of public interest disclosures.

Council's internal reporting policy and other information about the Act has been made available to staff through Council's intranet, staff bulletins, and staff induction sessions.

In the reporting period 1 July 2018 and 30 June 2019 Council did not receive any Public Interest Disclosures.

Government Information

(Public Access) Act 2009

Under section 7 of the GIPA Act, agencies must review their programs for the release of government information to identify the kinds of information that can be made publicly available. This review must be undertaken at least once every 12 months.

Council's Program for the proactive release of information involves the review of all access applications to ascertain if there is certain information that is continually being requested and if so deciding if that information can be placed on Council's website. As a result of this review, Council has not released any further information proactively.

Council has actively sought to place information on its website identified as being readily available (having regard to its format etc.) for viewing by the public. Council, as a practice, gives consideration to public access availability of all new projects, initiatives and developments.

Whilst Council reviews its decision about proactively releasing information on an annual basis, it will also release information proactively as and when required.
