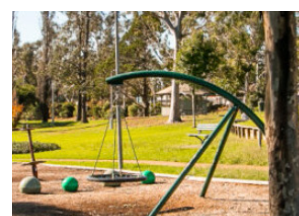


Lyrebird Sports Park, Nowra
