

Shoalhaven City Council is preparing Coastal Management Programs that will aim to protect and preserve the future of the Shoalhaven's coastline and estuaries.

Each Coastal Management Program (CMP) will:


- Identify coastal management issues and threats to the coastline and the community
- Recommend actions required to address these issues in a strategic way
- Detail how and when those actions are to be implemented.

Its purpose is to benefit the social, cultural and economic well-being of the people of the Shoalhaven.

**Each CMP will consider:**

- Historic events
- Current conditions
- Future trends including population growth, environmental conditions, and climate change

### Stage 1

Identify the scope of a CMP

### Stage 2

Determine risks, vulnerabilities and opportunities

### Stage 3

Identify and evaluate options

### Stage 4

Prepare, exhibit, finalise, certify and adopt the CMP

### Stage 5

Implement, monitor, evaluate and report
