## Executive Summary

This report provides an overview of Council's essential regulatory functions aimed at ensuring community safety, health, and environmental sustainability. Council is committed to regulating the key objectives in:

- public health;
- environmental protection;
- overseeing land use and built development;
- monitoring and enforcing parking safety;
- animal management;
- illegal dumping.

To strengthen community confidence, Council prioritises transparency in all compliance matters in line with our Compliance & Enforcement Policy. We commit to providing a comprehensive half-yearly overview that details our regulatory activities, enforcement actions, and community engagement efforts. This report will highlight successes, challenges, and areas for improvement, ensuring that our elected Council and community has access to clear and accurate information regarding regulatory compliance. By promoting an open dialogue and actively involving the community in these processes, Council aims to build trust and accountability, whilst reinforcing to enforcement across the Local Government Area.

## Penalty Notices and Warnings

A combined total of 5,669 penalty notices were issued by the compliance disciplines during the reporting period (Table 1). These penalties have a face value of \$1,336,924 and based on historical figures, it is anticipated that Council will receive approximately 70% of this ticketed figure.

A total of 62 warnings were issued during the period.

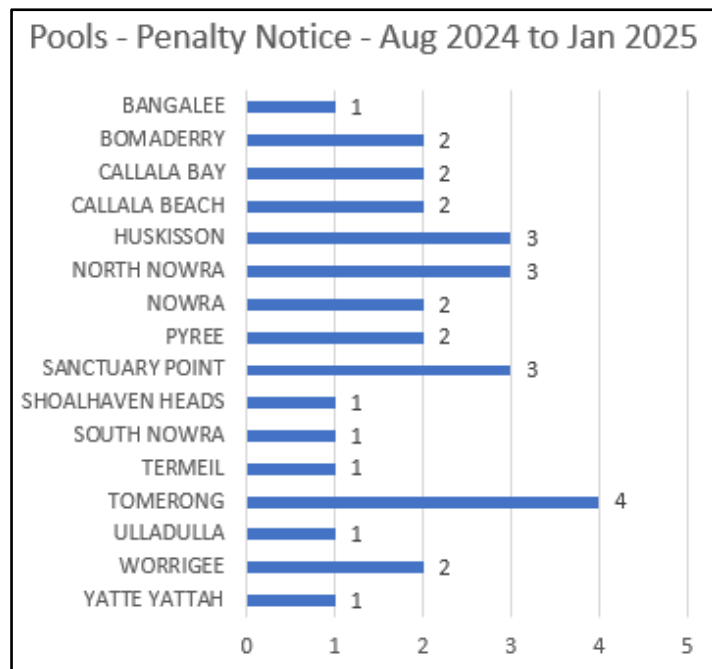

## Compliance

Seventeen Compliance penalty notices were issued during the reporting period:

- (a) Termeil (\$12,000): Three penalty notices were issued to a corporation being the property owner for unauthorised development including construction, land use and an unregistered swimming pool.
- (b) Huskisson (\$12,000): Four penalty notices two each, were issued to the property owner and the builder for unauthorised development relating to renovations and change of use for Airbnb. The renovations split the dwelling in two and made use of the carport to create 3 separate self-contained rentable spaces.
- (c) Vincentia (\$4,500): Three penalty notices were issued one was issued to a property owner and two penalty notices were issued to the builder for the construction of a first-floor deck without development consent.
- (d) Bomaderry \$6,000: One penalty notice for development not in accordance with consent (any other case) was issued to a corporation operating a service station other than approved.
- (e) St Georges Basin \$3,000: One penalty notice for development not in accordance with consent (any other case) was issued to an individual for operating a commercial gym out of a residential building without consent.
- (f) Nowra \$3,000: One penalty notice for development without consent (any other case) was issued to an individual for renovations to a heritage item.
- (g) Tomerong \$1,500: One penalty notice for development without consent was issued to an individual for constructing various sheds and storage buildings.
- (h) Ulladulla \$3,000: One penalty notice was issued to a property owner for non-compliance with a development control order requiring the removal of shipping containers.
- (i) Sanctuary Point \$1,500: One penalty notice for development without consent was issued to a landscaper for the construction of a retaining wall which encroached on a Crown Land boundary.
- (j) Bomaderry \$1,500: One penalty notice for development without consent issued to the property occupier for the demolition of unauthorised swimming pool without consent.

A total of 31 penalty notices were issued in relation to swimming pools during the reporting period for offences including swimming pools not being registered, not having a warning notice, failing to maintain a child resistant barrier, failing to comply with a written direction and swimming pools without a complying barrier (figure 1).

## Fire Safety

A total of three penalty notices were issued by Certification during the reporting period.

- (a) Huskisson (\$4000): One penalty notice issued to a building owner for failing to submit an annual fire safety statement 168 weeks overdue.
- (b) Vincentia (\$4000): One penalty notice issued to a building owner for failing to submit an annual fire safety statement 110 weeks overdue.
- (c) Bomaderry (\$4000): One penalty notice issued to a building owner for failing to submit an annual fire safety statement 159 weeks overdue.

## Environmental Health

A total of 13 penalty notices and two warnings were issued by Environmental Health during the reporting period:

- (a) Huskisson (\$16,000): Two penalty notices issued to a Business for Pollute Waters and Fail to comply with a Clean-Up Directive. During an event untreated sewage and wastewater was directed from collection tanks to the ground, the business also failed to adhere to Council's directives.
- (b) Burrill Lake (\$0): One warning issued to an individual for Pollute Waters. During roof cleaning the individual did not disconnect the downpipes from the stormwater system, wastewater was prevented from entering Burrill Lake. This would have equated to \$15,000 if issued as penalty notice.
- (c) Lake Conjola (\$6,000): One penalty was issued to a Holiday Park operator for development not in accordance with development consent for the removal and pruning of trees. One warning notice was issued for development without development consent for the removal and pruning of trees at known heritage listed site. Which would have equated to \$6000 if issued as penalty notice.



- (d) Sussex Inlet (\$440): One penalty notice was issued to a Food Business for Fail to comply with Food Standard Code for Animals and Pests.
- (e) Berry (\$3,520): Four penalty notices were issued to a Food Business for Fail to comply with the Food Standard Code for Cleanliness to walls, floors, fitting and fixtures, and equipment. No soap or paper towel at hand washing facilities, and unsafe food storage.
- (f) Callala Bay (\$15,000): One penalty notice was issued to an individual for Pollute Waters. During roof cleaning the individual did not disconnect the downpipes from the stormwater system, wastewater had travelled over 400m before it was prevented from entering a wetland by the intervention of Council.
- (g) Woollamia (\$3,000): One penalty notice was issued to a property owner for the development of a road without development consent.
- (h) St Georges Basin (\$660): Three penalty notices issued to a property owner for failing to comply with Local Government Act Order 18 for keeping a Rooster in a residential area.

### Examples of Environmental Health offences

## Compliance and Environmental Services Court Elected Penalties

The following matter has been court elected during the reporting period.

Three penalty notices for not comply with a development control order relating to substandard residential accommodation were contested in Nowra Local Court.

The following orders were made:

1. Matter 2024/411541 – convicted and fined \$3,000
2. Matter 2024/411645 – convicted and fined \$3,000
3. Matter 2024/411644 – convicted and fined \$3,000

The offender filed a notice written of pleading, the prosecutor is unable to bring an application of costs under section 215 of the *Criminal Procedure Act*.

Environmental Health Officers attended Nowra Local Court for one adjourned hearing for Pollute Waters. A guilty plea was entered prior to hearing commencing the penalty amount of \$4,000 was reduced to \$2,500.

Four food premises were listed on the NSW Food Authority's Name and Shame list for a 12-month period for six penalties. Premises are listed after payment of penalties issued has been received.

Environmental Health Officer – Soil and Water presented a toolbox talk to the CEO, Directors and Southern Branch of McDonald Jones Homes on the environmental risks of not installing and maintaining sediment and erosion controls.

## Ranger Services

### Rangers - Animal Management

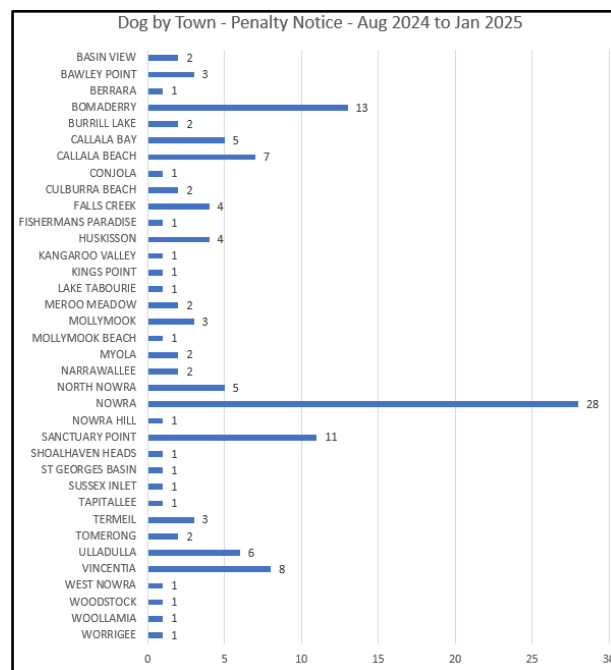


Figure 2: Dog related penalty notices by town for the period

There was a total of 130 dog related penalty notices issued for the period (not including registration offences). Figure 2 provides information on the penalty notices issued by town for the period.

The following additional comments are made:

(a) Development concerns: This represents the highest percentage of customer requests and includes development without consent, development not in accordance with consent and land safety issues such as landslides and fire damaged dwellings.

The requests received were from all areas of the Shoalhaven LGA, with the Basin area representing the highest total with 72 or 29.9% of the total requests received.

(b) Stormwater: Compliance receives a high number of complaints following extreme weather events. These complaints are often in towns without street drainage infrastructure and require officers to liaise with the customers to acknowledge their concern but often to advise that Council is not able to implement actions.

The requests received were from all areas of the Shoalhaven LGA, with the Southern Shoalhaven contributing to 60 requests or 24.5%.

(c) Swimming pool compliance: This includes concerns raised by members of the public, referrals from private certifiers and Council's proactive inspection obligations. Council's Compliance Unit continue to enforce swimming pool legislation in accordance with the Council resolution (MIN22.946) to take a zero-tolerance approach to swimming pool breaches and have attended a high volume of unauthorised pools during the quarter.

Zero warnings were issued for swimming pool offences in the reporting period.

Compliance continues to streamline processes internally with the intent of reducing office-based time and increase the number of pools being inspected each quarter. For the half-yearly reporting period Council conducted 39 separate inspections.

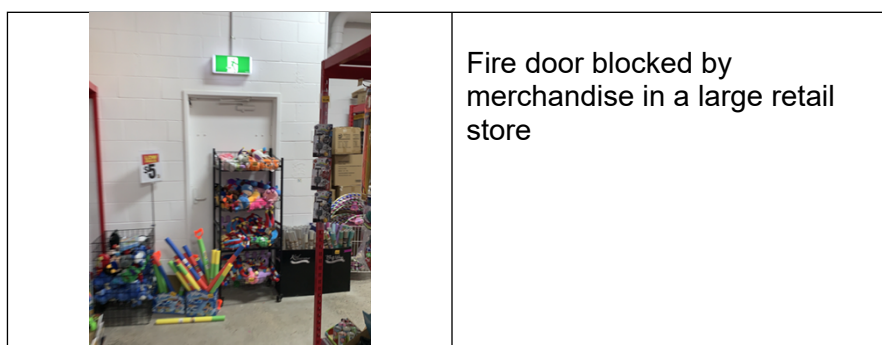
## Fire Safety

Council has an obligation to ensure commercial buildings are safe for occupants in the event of a fire, ensuring both egress requirements comply, and statutory fire safety measures are not only installed, but functioning as required.

In this regard, Fire Safety staff are reviewing and taking enforcement action against building owners whereby the submission of annual fire safety statements are several years overdue.

Fire Safety received 80 enquires through Request Management with an additional high volume received directly by staff. This includes requests for fire safety schedules, enquiries about building audits and concerns from the public.

A total of 328 annual fire safety statements were received during the reporting period and staff continue to follow-up on those due but not submitted.



Fire Safety staff are also part of Council Fire Safety Service Review in collaboration with Corporate Performance, Reporting and Corporate Information Systems and City Development Business Support with the aim to improve customer service and efficiency.

## Environmental Health

Environmental Health received 495 Customer Requests in the reporting period (Table 3).

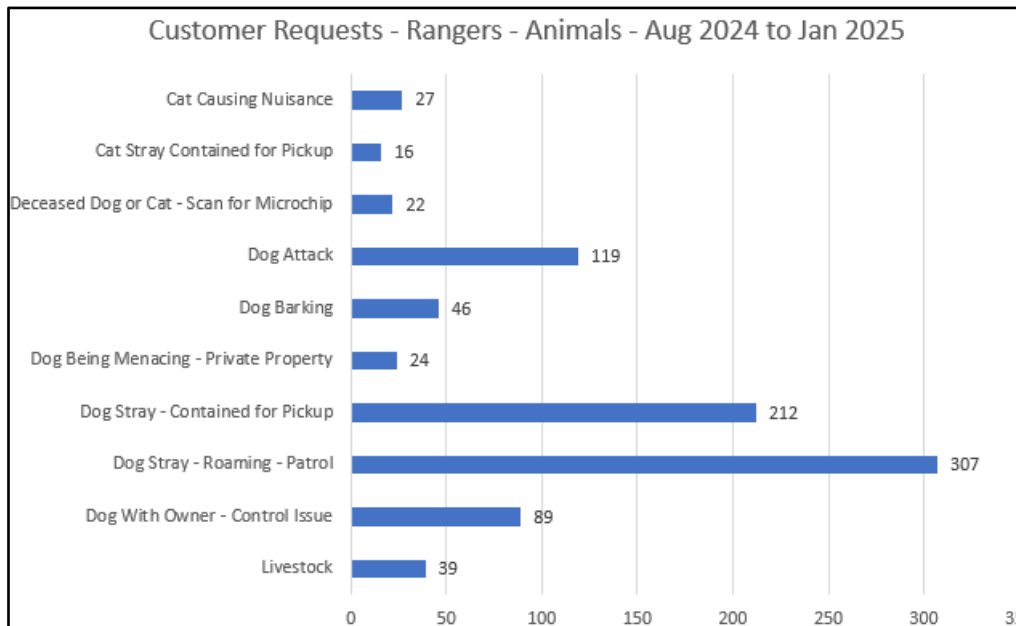

The following provides a breakdown of the aspects of the customer requests that Environmental Health received:

- (a) Air, Land and Water Pollution (inc. Sediment & Erosion): This category represents one of the highest percentages of customer requests received by Environmental Health and includes backyard burning, odour and smoke; pollution to waters and sediment and erosion pollution from building sites.
- (b) Contaminated Land enquiries: Environmental Health administers the Potentially Contaminated Land (PCL) layer in GIS and provides advice internally and guidance to members of the public.
- (c) Noise Pollution: Noise disturbances from prescribed articles such as air conditioners and pool pumps as well as musical instruments, poultry, and licensed establishments.
- (d) Public Health enquiries: This category includes food premises, on-site septic systems, overgrown properties and hoarding and squalor. Complaints about overgrown properties take up a lot of resources at this time of the year.
- (e) Short Term Rental Accommodation (STRA): While STRA's are administered by NSW Fair Trading, Environmental Health will respond to complaints with letters outlining responsibility of owners and provide advice to customers.

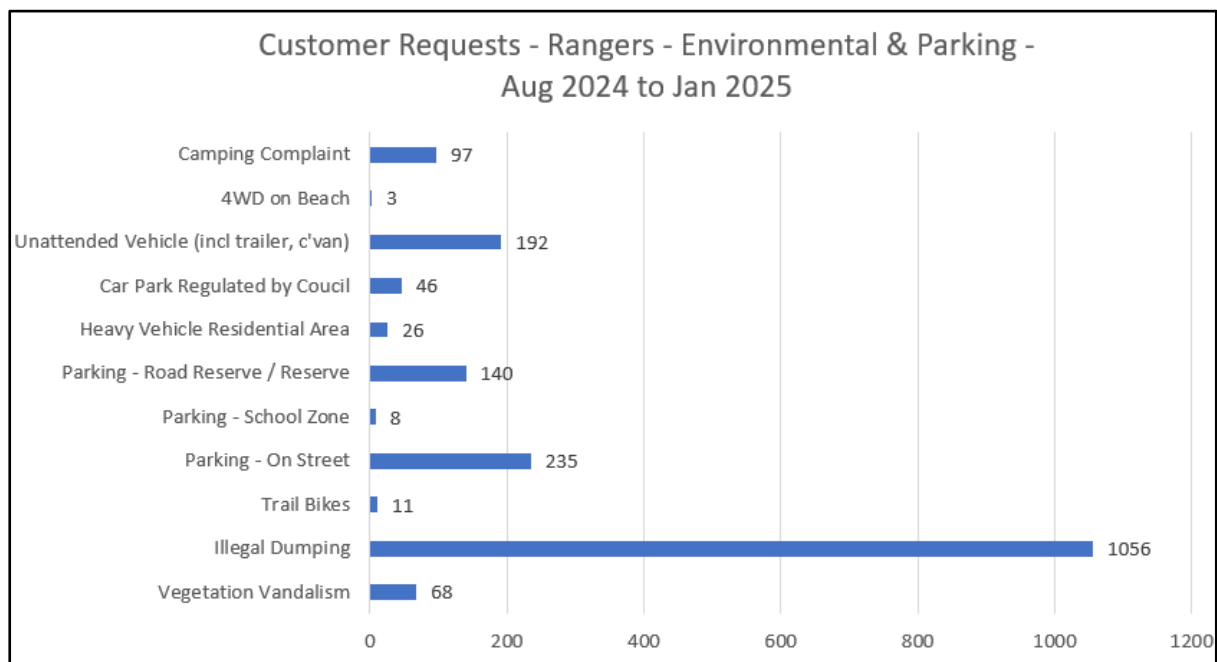
A total of 901 animal management complaints were received for the quarter (Figure 4).

## Ranger Services - Environmental and Parking

Rangers attended 1,882 environmental and parking complaints (Figure 5).

The following provides a breakdown of the aspects of the customer requests that Ranger Services received:

- (a) Vegetation Vandalism: Ranger Services received 68 reports of vegetation vandalism and 10 are still under investigation. Rangers continue surveillance of

these vandalised areas in accordance with Council's Vegetation Vandalism Prevention Policy.

- (b) Proactive Beach Patrols: Ranger Services completed 1,844 beach patrols during this quarter. A number of dog owners were spoken to during this period with Rangers identifying 1,355 compliant dogs and 167 non-compliant dogs. Enforcement action and education is undertaken when offences are detected.
- (c) Proactive Patrols – Other: Ranger Services completed 2,014 patrols with categories including Asset Inspection (RID), Asset Protection, Camping, CBD Foot Patrol, Illegal Dumping, Parking, Schools, Shopping Trolley, Unauthorised Signage, Vegetation Vandalism.

**Examples of incidents investigated by Ranger Services**

**Ranger Services - Report Illegal Dumping (RID)**

Illegal Dumping: 1,056 incidents were reported to RID Online including 88 duplicate jobs which often are re-reported if the rubbish remains in situ for some time. Of this figure, 188 incidents remain open pending further investigation. Strategies to reduce and prevent illegal dumping includes collaboration with other public land managers and Local Aboriginal Land Councils in the Shoalhaven. Rangers conducted two deployments of covert surveillance cameras during the reporting period at illegal dumping “hot spots”.

The estimated cost to Council for the removal of the waste reported for the reporting period is \$132,655.31 with a total clean-up cost for all land managers of \$207,667.45.

## Ranger Services Animal Shelter

The animal shelter continues to have positive outcomes and challenges to overcome when providing the best for animals in care.

Non microchipped cats still equate to around 85% of stray cats coming into the shelter, where the percentage of non-microchipped dogs is around 30%. The percentage of cats reclaimed by owners is still less than 10% with dog reclaims are around 50%.

While cats are legally around to roam in NSW, the issue with the number of cats roaming onto other people's properties causing problems is ongoing. Too many cat owners allow their un-desexed cats to roam and therefore an influx of kittens during the warmer months continues.

Due to the increase in dog adoptions and decrease in stray dogs entering the shelter, the surrender wait times had been as high as an 18 month wait time. Currently there are no dogs on the surrender wait list, which is a fantastic outcome.

Incoming Companion Animal forms from the public are processed at the Animal Shelter. Pet owners can manage their own data via NSW Pet Registry, but the option exists to utilise Council for this service. Council is required to update the information within seven days of receipt. # Education

## Compliance

The compliance team have undertaken the following education measures in the second half of 2024.

- a) October 2024: Designed new posters and a flyer with the slogan ‘a pool that complies, saves lives’ to educate pool owners about their legal obligations. These posters were hung in the Nowra and Ulladulla administration buildings.

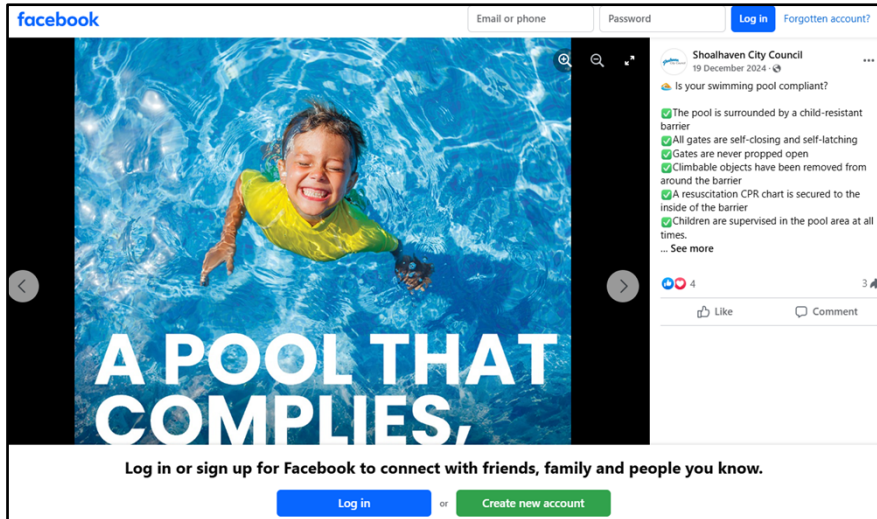


- b) November 2024

- i. Issued a media release encouraging swimming pool owners to ensure they have a compliant, child-resistant barrier installed around their pool ahead of Summer. ([A pool that complies, saves lives | Shoalhaven City Council](#)). This was published by the South Coast Register, Milton Ulladulla Times and 2ST.
- ii. Councillors were informed of the new campaign through the Councillor Portal and Councillor Newsletter.

- c) December 2024

- i. Created a social media tile with the fresh messaging and posted information about swimming pool compliance across Council’s pages. ([\(2\) Facebook](#))



ii. An article promoting the campaign was included in the Community Newsletter 'In Your Neighbourhood' issued on 20 December 2024.

d) Ongoing for 2025

i. Planning is underway for an educational social media video that explains how to ensure a swimming pool complies with NSW legislation.

(a) Responsible dog ownership project:

- i. Videos providing education to pet owners are available on Council's website, Facebook and Instagram. The videos will continue to be shown at Huskisson Pictures until 14 June 2025.

(b) Keeping cats safe at home project:

- ii. The project finished in December 2024. \$85,000 was provided to Council for the project and Council contributed \$10,000.
- iii. \$75,000 was spent on cat desexing. 216 cats were desexed during the program from July 2022 to the conclusion of the project on 31 December 2024.
- iv. \$10,000 was spent on a cat containment competition and 16 Catnet containment systems with accessories were given to 16 cat owners.

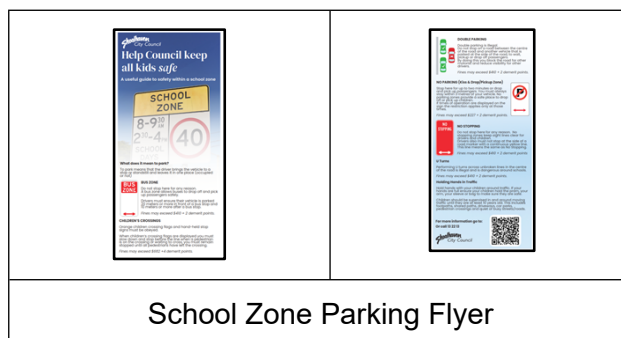
(c) School Safety Parking Project:

- i. On 6 June 2024 research commenced to develop a school safety project. School Safety Operation is a 12-month behaviour change and educational initiative. It aims to reduce parking offences in school zones and generate voluntary compliance by providing education to parents, children and schools about the importance of safety in school zones. Another objective of the project is to improve the perception of rangers who undertake patrols in these areas to detect and deter offences and highlight the importance of safety.

The project is a collaboration between Ranger Services, the Road Safety Officer and the Communications team.

The Shoalhaven LGA has a total of 39 schools and more than 14,000 students travelling to and from schools every day. This highlighting the need for the school safety operation as the number of schools and volume of students traveling to and from school can see road safety issues arise.

- ii. A flyer has been created to provide to schools and parents electronically and also for Rangers to hand out when undertaking school parking patrols. The flyer explains the purpose of each sign type erected in school parking areas to easily inform parents of regulations and their purpose to help keep kids safe.
